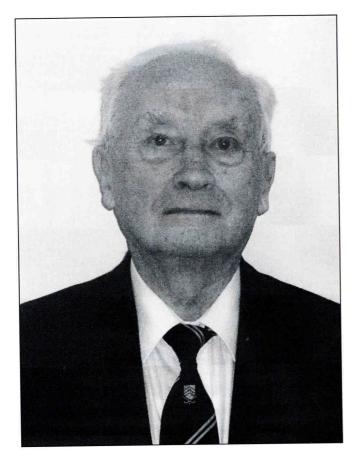

1. Notice of Meeting

Keith Morgan welcomed the members to the AGM and read the notice of Annual General Meeting

Keith Morgan apologised for some printing errors in the accounts. Keith apologised to Dereck Redwood who had emailed in his complaints about the errors. It was suggested that an apology be offered to the auditors.

Keith Morgan then addressed some written questions received regarding the accounts:

Tony Nash - Page 22 - Rental of Cardiff Arms Park suggests that the Blues did not pay the full rent for the year and this is confirmed by page 29 where the Blues are shown as a debtor - owing £9,429.00. However Note 3 on page 26 shows that the Blues were charged an extra £10,890 in 2017 as a" late payment interest charge". Question A - Is there a similar Late payment Interest Charge for 2018 taking account of what appears to be a late payment of rent in 2018? If not please could you clarify why?

Keith Morgan – I can confirm there has been a post balance sheet charge, and there is another £3000 which has been added to the debt.

I know that the rent was excessively discussed at the last AGM, it was after that meeting I came on board as Chairman. The first thing I did after my appointment was to get the debt down from £140k to about £30k. But since then, they have slipped back into their old ways. We have only received £18k since September and they now owe us £115K, if they do not pay anything this month, at the end of the month they will owe us £150k.

Question B - I can see Recharged Expenses Debtor Cardiff Blues in the Debtors section - but this description implies it is something different - please could you explain the difference between a Late Payment Interest Charge and a Recharged Expenses Debtor charge?

Keith Morgan – I can confirm that it is different. Under the lease we can reclaim from Cardiff Blues the cost of maintaining and renovating the Bowls green during the season, the cost of printing for the rugby AGM and CAC AGM

AN Other – Mr Chairman, you mentioned about the printing of the accounts, but the glaring error is the debtor on page 27, which is listed as £9429 but should be £49429

Keith Morgan – you are correct, I do have a correct copy of the accounts here if you would like to inspect them.

6. To elect the Vice Presidents

Proposed – Richard Cottell Seconded – Clive Davies

7. To Appoint the Auditors

Keith Morgan apologised for the lateness of the AGM. Although the auditors came in during the first week of July and received the final accounts in late December. He explained that we had spoken with them, and have asked that they action our accounts more quickly, it is Cardiff Athletic Clubs intention to hold the AGM in November this year.

8. To confirm the election of the members to the Management Committee

Keith Morgan - Each section is asked to put forward a proposed member to sit on the Management Committee. The number of vacancies for each section is one for Bowls, one for Cricket, one for Hockey, two for Rugby, and one for Tennis. As you can see there are two nominations for the Tennis section and now we have to have a vote. As many of us do not know Mr Nash and Mr Whittle, I now invite them to give us a quick summary of why they should be elected. After that I will ask Mr Nash & Mr Whittle to leave the room and a vote will be taken.

Des Whittle - Good evening & many thanks to the Athletic Club management committee and members of the Athletic Club for allowing me to address you tonight at this AGM.

This is an unusual situation for me and for the Tennis Section as, on the 21st January, I was voted into the Athletic Club management committee post by the Tennis Section committee, by 7 votes with 1 abstention. I do feel that the process this evening, loses sight of this fact.

Concerning myself, I joined Whitchurch Tennis club in the early 1990's was a committee member and Treasurer at Whitchurch Tennis Club for many years before

moving to Lisvane Club where I have been a member for over 10 years. During this time I have held several posts on the section management committee:

I was the House & Grounds representative for two years, followed by three years in my current role as Membership Secretary.

During this time, I have sought to increase membership of the tennis club by encouraging people attending the club for coaching to join. I also helped to introduce a family membership package to encourage parents to bring their children to the tennis club

I meet with prospective members and give them an induction about the club, the role of Cardiff Athletic Club and its financial support especially concerning our new courts for which the tennis section passes on its most sincere thanks. I have represented the club at local festivals and functions to actively seek out new members.

I have also attended seminars run by Tennis Wales to gain knowledge and seek advice in relation to the general running of the club and fund raising.

I have also been the Mens' 2nd. Team Captain & last year was awarded the Club Member of the Year award.

I always help out at social events, and I am the unofficial club photographer for events and articles written in the local magazine.

The area in Lisvane is expanding and with the new Churchland Development of 2500 new homes, while the Club is doing well for memberships at the moment, there is no room for complacency, and I strongly believe that we can increase our membership towards the 300 mark.

You can see from the above, that I have taken a pro active role in the running of the tennis section and other tennis clubs. I would like to use this knowledge & experience to be a representative on the Athletic Club management committee. With regard to the CAC committee I feel that I can bring a new perspective to meetings. Over the past few years I have built up a good working relationship with Abbie Gibbins, the Athletic Club Secretary and I feel that continuity is important for the future.

The Athletic Club represents many different sports in Cardiff, of which tennis is just one. All the sections need to work together for the good of Cardiff Athletic Club, and I intend to do just that.

I hope that by making sensible decisions, acting with common sense, good faith and making reasoned arguments, I would become a valued member of the Cardiff Athletic Club Management Committee.

Many thanks for your time.

I have been a member of the club for over 10 years and I am the Chairman of the Tennis Section.

I originally joined the tennis club section committee in order to play a more active role in the club particularly with regard to increasing the number of junior members as these are the people who will ensure the club will grow and thrive in future years. My daughter is a junior member who also plays for one of the club's representative teams so I have been able to help providing transport to away matches across South Wales and assisting with the hospitality that the club offers to visiting teams. My time on the committee has included a variety of activities ranging from tree planting and preparing burgers through to organising the Club's Finals Day and advising on the coaching contract – all the things that ensure a club continues to run smoothly but usually unseen by the wider membership.

My application to join the Cardiff Athletic Club Management Committee is based on the skills and experience I can bring from my professional life as the Chief Executive of a charity that provides homes for those in need and a variety of community services designed to empower young people to fulfil their potential and become enablers for their local community.

I volunteer at a Youth Club that my organisation runs in one of the most deprived and diverse areas in the UK. We are using sport to steer young people away from being passive consumers of social media and away from the gang culture that threatens the future prospects of many young people from challenging backgrounds. I strongly believe that all sports clubs have an important role in engaging young people and inspiring them towards a healthy life style.

I have significant governance and financial management experience through my Chief Executive role and this includes fulfilling the role of Company Secretary of the registered charity and for a commercial property management company that we provide services to.

I have a wide ranging interest in property development and regeneration – I spent 5 years on the steering group that delivered a £37 million urban regeneration scheme in the West Midlands. The scheme was a huge success and we won UK wide awards - the Best Regeneration Scheme Award and Best Residential Scheme in 2014. I have also delivered a number of new developments across South Wales - the best known locally is a £6 million award winning retirement scheme on Aberavon beachfront. I feel I can use my knowledge and experience of development to bring additional expertise to the Management Committee particularly as the club is faced with having to make some far reaching decisions regarding the existing ground. I am Cardiff born and bred and started following Cardiff RFC in 1977 so like 99.9% of the clubs membership I want to see the Blues playing in their historic home. Equally important to me is the need for transparency and the club keeping its members

committee to publish the minutes of their meetings so that members had a better understanding of the management of the club. The minutes of the tennis section are published on the Tennis Club website and this is something I strongly believe that members will appreciate. Like many members I am frustrated when the only information I can find about the future of the Arms Park is in the local newspaper.

So to summarise I have applied for a role on the Management Committee because:- I have a strong commitment to youth and ensuring the club has a strong and vibrant future through engaging with its junior members — who in 20 years time will hopefully be sat in the 2039 Cardiff Athletic Club AGM!

I have significant experience in running a professional organisation in a voluntary/charitable sector and a thorough knowledge of compliance with regulatory and financial standards as well as a sound understanding of large scale redevelopment schemes.

I am committed to promoting openness and ensuring members of Cardiff Athletic Club have a full understanding of the challenges and opportunities that face the club.

Keith Morgan then requested Messers Whittle and Nash to leave the room.

Harriett Davies – At the beginning of Mr Whittles statement he said that he was elected by a majority and then he wasn't the only nomination, could somebody please explain how that happened?

Keith Morgan – The way it has always worked is that each section chooses who they would like to represent them on the Management Committee. For example, rugby has 2 representatives, if I wanted to challenge those, I would put myself to stand against them. Tennis had a vacancy because Steve Finch was standing down, the Tennis committee met to decide who replace him. Des Whittle was nominated by the Tennis committee, by 7 votes to one abstention. As Mr Nash still wanted to stand for Management Committee, he has decided to stand against Des, because under the constitution, he is entitled to.

We now have to have a show of hands to elect one of them onto committee, may we have a show of hands for Mr Des Whittle, and now for Mr Nash.

The show of hands indicated that Mr Des Whittle had an overwhelming majority and was elected onto the committee.

10. To transact any other business

Written question from Paul Brewer – What progress has been made regarding the leasehold negotiations with Cardiff Blues? If the situation is still unresolved, then I would like to know what plans CAC has regarding the development of the ground and the playing of rugby football at CAP?

Keith Morgan – We will fully address this later in the meeting.

Written Question from Paul Brewer – I would like to know why the members are locked out of our clubhouse until 2 hours prior to KO on Regional Match days, as all necessary security checks can be carried out at any time on entry to the clubhouse.

Keith Morgan – At the start of the season that was the case, however the matter has now been resolved. We made representation to the Blues asking them why they were keeping members out from their club. They listened to our request and now the Clubhouse is open at a reasonable time prior to kick off. I urge all members, that is there is something that you are not happy with, please speak to us and we will do what we can to resolve it.

Written Question from Jeremy Sparkes - Last year, and the previous year, I asked about the disenfranchisement of members who - in many instances for reasons beyond their control such as caring responsibilities or shift work - were unable to attend Meetings, and asked if the Committee would address the way that members can use their vote (eg. some form of proxy vote). The Chair said that this would entail changing the Constitution, may need legal advice, and that it would be added to the agenda for the next Management Meeting (cf. page 16 of the Minutes & Annual Report booklet). Would the Chair please would update the Members on this issue.

Keith Morgan – we have discussed this a Committee and we have taken advice from our legal team, we would need to change the constitution of the Club, which means that we would need to have an EGM, which will cost in excess of £1000 just to circulate to the members. With the property negotiations that have been going on over the last few years, we as a committee think that proxy voting, is very dangerous. Unless the meeting wants otherwise, we will not be introducing proxy voting.

There was no motion from the room in favour of proxy voting.

Gareth Moore – Would it be possible to not hold the AGM in half term as I know many people who were not able to attend today as they are away with their families.

Keith Morgan – We understand and it was difficult for us to get an agreed date this year. As I have previously stated, I am hoping that this years AGM will be in November this year.

Harriett Davies – Would it be possible to send in an absentee vote in a letter format?

Keith Morgan – this takes us down the road of postal voting and could be something that we may need to consider in the future.

David Allen - Though we have yet to receive any definitive information, I would like to make the following proposals:

- 1. The terms of any future lease, licence or other arrangement concerning Cardiff Arms Park shall contain a provision requiring any professional/semi-professional rugby side whose home ground is Cardiff Arms Park to retain 'Cardiff' in its name. This obligation shall continue for the full term of the lease/arrangement.
- 2. The terms of any future lease, licence or other arrangement concerning Cardiff Arms Park shall contain a requirement that the ground continues to be named as 'Cardiff Arms Park'. This obligation shall continue for the full term of the lease/ arrangement but shall be subject to secondary naming rights.

The first would not preclude any new entity being called, for example, the Cardiff Dragons, Cardiff Ospreys or Cardiff Region etc., but would preclude it being called the Blue Dragons, Glamorgan, 'the Blues' or some such; I include the RFC in the proposal for good measure, though realise that any threat to them is less likely.

The second would enable a similar arrangement to exist as when the BT sponsorship was in place but would rule out, for example, any suggestion that the ground name could be altered after a set period had elapsed.

Assuming that the redevelopment and lease will at least be mentioned at the AGM tomorrow, I would be grateful if you would consider the above as 'fairly arising out of the Agenda' as per paragraph 18 (d) of the CAC rules.

Although I am sure that much of this has already been discussed, it has not been communicated to us as members.

Brian Bennett – you can ascertain the feeling of the meeting, but you are not able to put motions forward unless they are included on the agenda.

Keith Morgan – In all of our copious negotiations over the years, these things are terms that we have put forward as non-negotiable in our dealings with the WRU and the Blues. The legality of it, when we come to sign any paperwork I do not know, however this is what we will be pushing for as we do not want to lose our identity.

There is an article in the Paper today about what we are doing. Some of it is very inaccurate and made up, however some of it is very accurate, which is disconcerting when we sit in meeting, and are sworn to secrecy, and then three days later, we read in the papers this is what Cardiff Athletic Club are doing. I am sure that it is no

coincidence that it's released on the day of our AGM, and I would like to point out that on the day of our AGM last years, the Blues announced that they could no longer work with us and were moving to another ground.

In the last few months we have been having some negotiations and have had some fantastic plans drawn up, but we are not running to the press and telling them what we are doing as there is an element of confidentiality to it. We are a long way off signing any agreement, and before we do sign anything, we would have to show the presentation to the members for you to give it your approval.

We have met with the council and we have been told what we can and cannot do. We have met with the WRU so they know exactly what is going on, and we have met with the Blues so they are informed, and today we are going to tell you we are planning so everyone is informed. We want an improved ground, the roof on the south stand need major improvements. The north stand also needs to be improved. To do that we have to develop other parts of the ground to give us the money to do what needs to be done. We do not want a huge capital sums sitting in the bank, but we do want something that is going to generate enough income for all of the sections to be well looked after for the foreseeable future. For those of you here who are hockey members, you will know that the hockey section is currently sharing a ground with Cardiff Met, but really they should have their own home. Any development of the ground will mean that the bowls section will be relocated, but in speaking to the council and getting them on board, they will help us to find some suitable sites.

We have appointed a firm called Savills and they are negotiating on our behalf. They have met with the Blues, and with us, and they will meet with the WRU, they will negotiate with the developer. This site is quite complex, and there is a possibility of developing part of it with the WRU, part with a developer and part with the council. Regardless of what you read in the press, that is where we are at. It is moving at a reasonable pace.

Regarding the WRU deal, they had a non-negotiable clause in that they wanted the freehold of the ground as part of the deal. We did not want to insult you by even asking members if you wanted us to sell the freehold. All of the members that I spoke to at the time, in excess of 150 members, all agreed that the freehold was not for sale. If we sold the freehold Cardiff Athletic Club would have no say in what goes on in this place.

Chris Collins – Where do they get their information from?

Keith Morgan - I do not know but it happens all of the time. When we had a meeting on a Monday evening with the WRU, we told them that there was no way we were selling the freehold. I had a phone call on the following forming from Kate Morgan at the BBC who wanted me to give an interview about the WRU deal. I told her that we were not going to give an interview on the subject as it would be discourteous to the WRU. She rang me later that morning and again requested an interview, I reiterated that we did not want to give an interview, and she informed me that the whole story had been published in Wales Online. Someone has a hotline straight to the press.

Tony Espoti – Doesn't this suggest that the WRU are trying to bring discontent amongst the RFC and the Blues to some extent. From what you have talked about and this lease deal, it seems to suggest that it's the WRU playing people off against each other, and that is what we are seeing a lot of with leaks about project reset. If anything it seems to be it is the WRU that cannot be trusted, and as much as that might not sit well with people, it is something that needs to be considered going forward that the WRU do not have the best interests of our game at heart.

Keith Morgan – I think you are right, Cardiff is a very small place where everyone knows everyone. It is worrying that when you have a confidential meeting within 12 hours its all over the press. If I did find out who it was they would not be on management, or even in the Club. It undermining us, as you have read in the Echo what we intended to tell you tonight. We would never talk to the press before talking to the members. The biggest criticism that I have of the Management Committee in the 15 years I have been on it is that we have not been noisy enough in the press. The Blues have kicked us from one side to the other, and we have been called names, but we never go back and fight.

Ellis McLucas – Can you confirm the debt that they owe us? Is it £150k?

Keith Morgan – It is about £113k at the moment but the next rent is due on 25th March.

Ellis McLucas – Is that in the public domain? Because as far as I can see the press are stating that Cardiff Athletic Club were stopping things moving on, when we are trying to do business with a company that don't want to pay their debts.

Keith Morgan – I have had several conversations about this and with the new Chairman Alan Jones, but his attitude is well we have not got it so you can't have it.

Fred Davies – We should encourage them into administration

Keith Morgan – The people here have the right to have their say, and I would like to pass you over to Chris Nott

Chris Nott – The Cardiff Athletic Club Committee could start proceedings to put them into administration, or winding up or liquidation process. That would be an enormous thing for Cardiff Athletic Club to do. It was felt by the Committee that it was something that should be discussed here, because we have been told by the Chief Executive that there is the prospect of payment soon. But payment has not been coming for some time.

There is a second option, to redevelop the ground we have to run the lease down, there are 3 years left. The Blues would say at the end of those 3 years, they have a right to renew it. We would say we will contest that right, and in law, we would win that contest. But we would have to have that contest.

What we want is the right to start redeveloping now. We want the Blues to play here, but on new terms. What the Committee would like to put to you, the members, is if the Blues don't pay the rent, then they have to give us the lease back. We would then give them a license to play rugby in this ground. If they don't give us the lease back, and they don't pay the rent, then we will start winding up proceedings.

A.Membern - Could we start taking the car park money straight away if we get the lease back?

Chris Nott – if we get the lease back we could start taking the car park money straight away.

What the committee is going to ask this meeting to do, is to back it with a resolution; Unless The Blues pay in full the rent due to CAC, or surrender their lease of Cardiff Arms Park and swap it for a match-day playing licence on mutually acceptable terms, CAC's Management Committee shall be authorised to commence winding-up proceedings.

Keith Morgan – We feel that we have been more than generous, if you look back at comments made at last years AGM about the rent not being paid, and here were are again talking about the same thing 12 months later. It will come to a point that we will have to start drawing on our investments because we have liabilities of our own to meet. All of the sections rely on CAC, and we do not want to start taking money from our deposit accounts, when we should be sitting on £140k in the bank

Tim Lawrence – For the last five or six years we have had the same arguments meeting after meeting. The Blues have been taking the mickey, they seem to have no intentions of following through with what they owe us, so why don't we do something back to them. Maybe then, they will begin to take notice of what this club wants.

Keith Morgan — To be fair to the Blues at the moment, you have to look at this from all angles. They got themselves into a mess because of mis-management. They have been relying since last August on Project Reset. They have been waiting for this windfall of one and a half to two million pounds and the WRU keep pushing the goal posts further and further away from where they started. There are players worrying about paying their mortgage in June because they do not know whether they have a contract. The regions cannot pay the players beyond May if they are out of contract. It is a dreadful state of affairs. It's not all down to the Blues, some of it is historical.

Last year they did well and paid over £100k to us in the space of 2 months, and we thought we were on the right track with them. Since then we have had £18k in 6 months.

So now we look to you, do we get the authority of this meeting to go to options a b & c. We have the power to commence winding up proceedings, but that is not something we would take lightly, if that the feeling of the members at this AGM, we would have a stronger mandate than just the view of the Committee.

Harriett Davies – They say they do not have any money, we have something that they can give back that costs them nothing and we give them a licence. It makes a huge amount of sense as they will not have to worry about paying, they won't get the car parking amongst other things, but they won't owe it and incur interest. I think that it is really good advice.

Keith Morgan – The way forward is definitely to give them a licence to play here, and we can go back to us running the ground. We do not want them to leave this ground. We want them to play here for as long as the RFC are going to play here.

Gareth Morgan – I am only informed by the media, but my understanding is that the RFC need a lease in place, and it to be longer than 5 years, for them to remain in the Premiership. It would be a real shame to win the league this year, and then have some covenant that stops us from playing here.

Keith Morgan -Cardiff RFC will always play here.

Gareth Morgan – The lease that we are all talking about here, was signed in 1997 and was not with the Blues but with Cardiff RFC.

The Blues have a responsibility to look after Cardiff RFC as it stands at the moment. We have looked at various scenarios, where maybe, we could take the running of the RFC back to the Athletic Club, but obviously with the enormous costs of running a semi- pro team, we would need other sources of income.

With no more questions the meeting was concluded at 20:08

Chairman's Report for the year ended 31st May 2019.

I begin my report by recording with sadness the passing of John Smart, Ray Cheney and Terry Gooding. I apologise if there are any others that have been omitted.

From a sporting perspective it has been a successful year with continued development of young players and in some ways this is a better reflection on the achievements of each section than purely results.

As special mention this year for Cardiff RFC who finished as runners up in the Principality Premiership League and won the Welsh Cup with a tremendous victory over league champions Merthyr.

We also saw changes in the club house where Karl Williams moved to a new position with Cardiff Blues. I know that Karl is enjoying his new role and we wish him well for the future.

Our new Clubhouse manager is Jason Chapman, who joined us after a successful career as a manager with Spiro's organisation. Jason has settled into his role quickly and I hope that he will receive the members support for the various initiatives he has introduced

Relationships with Cardiff Blues were strained at times during the year due to a failure to pay rent and admin charges when due. At the AGM in February 2019 this matter was discussed at length and resulted in much publicised action being taken by the Management Committee to secure payment of arrears.

I am pleased to report that all arrears were cleared in the current year and a constructive dialogue has resumed between CAC and Cardiff Blues regarding improvements to Cardiff Arms Park and associated facilities.

1. Statutory information

Cardiff Athletic Club is governed by the Club Rules. The Club operates from Cardiff Arms Park, Westgate Street, Cardiff, CF10 1JA.

The financial statements are presented in Sterling (\mathfrak{L}) which is the functional currency of the Club and rounded to the nearest pound.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

2. Basis of accounting

These financial statements have been prepared in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland". The financial statements have been prepared under the historical cost convention as modified by the revaluation of certain assets. There have been no material departures from Financial Reporting Standard 102 1A.

Income

Income is accounted for on a receivable basis.

Fixed assets

Freehold land and buildings, and other tangible fixed assets are stated at cost, less accumulated depreciation where applicable.

Heritage assets

Heritage assets are held principally for their contribution to historic knowledge and culture. Assets are measured initially at either their cost, or valuation if donated, subject to any depreciation or impairment. Where information on cost or valuation is not available and can not be obtained at a cost commensurate with the benefit to the users the assets are not recognised.

Expenditure incurred to preserve or prevent further deterioration of the collection is recognised as it is incurred.

Investments

Investments are recognised initially at fair value which is normally the transaction price excluding transaction costs. Subsequently, they are measured at fair value through profit or loss if the investments are publicly traded or their fair value can otherwise be measured reliably. Other investments are measured at cost less impairment.

CARDIFF ATHLETIC CLUB NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MAY 2019

Depreciation

Depreciation is provided at the following rates;

Straight line basis on fixtures / ground equipment, office furniture / equipment, tennis court / equipment at a rate of 25% per annum.

Straight line basis over the term of the lease in respect of land and buildings – leasehold.

No depreciation has been provided on freehold land and buildings. The Cardiff Arms Park is let under a full repairing lease and has to be maintained in accordance with Sports Ground Legislation, such that the value does not diminish over time. The Management Committee are of the opinion that the market value of the land is greater than the value at which the land and buildings appear in the accounts. As a result, the corresponding depreciation would not be material and therefore is not charged in the Income and Expenditure Account. The Freehold Property at Lisvane is newly built and is subject to a maintenance period.

The Management Committee perform an annual impairment review in accordance with the requirements of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland" to ensure that the recoverable amount is not lower than the carrying value.

Current tax

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date. Current tax liabilities are not discounted.

Debtors and creditors receivable/payable within one year

Debtors and creditors with no stated interest rate and receivable or payable within one year are recorded at transaction price.

Grants received

Grant received in respect of capital expenditure are treated as deferred income and are credited to the profit and loss account over the useful life of the asset to which they relate to.

Loans

Cardiff Athletic Club received a loan to assist with the financing of the expansion of Lisvane Tennis Courts. This loan has no interest attached to it and is not secured. The loan is repayable in 6 monthly instalments over a 10 year period.

CARDIFF CRICKET CLUB CHAIRMAN'S REPORT 2019

2019 was a landmark season for the club, celebrating 200 years since we were founded in 1819. We have had a successful year, and as I write this, we are about to embark on a short tour to La Manga.

The 1st XI showed periods of outstanding cricket but lacked the consistency to properly challenge for top spot. Finishing a credible third in a strong league, we continue to field a young side with an average age of around 20. Captain Greg Holmes was the stand out batsmen amassing 1,046 runs, scoring 4 centuries at an average of 55. Osama Subhan led the bowling attack taking 35 wickets at an average of under 20, and looks a great prospect. In the Welsh Cup, we lost in the semi-final for the second year running, which is habit we don't want to repeat! Our second XI under the watchful eye of Dan Quick finished a respectful fourth and was unlucky not to finish higher due to localised inclement weather with only a few weeks to go. Stand out batsman were Tom Young, Ollie Hughes, James Meggitt and Richard Sen, who all showed promise, and will no doubt be regular 1st XI players in the coming years if they continue to progress. The bowling was led by Dan Quick, who took 20 wickets over season, ably supported by Dale Boorman and Amir Mohammed taking 13 apiece.

Dave Ricketts mighty 3rd XI gained deserved promotion, finishing second in their league. He led from the front taking 23 wickets at an average of 16, while Fazil Rabi Noor took 16 wickets economically, and the evergreen Mathew Phillips taking 15 wickets. The skipper also led the way batting steadily scoring 376 runs in 14 innings, ably supported by Mathew Phillips and Jonathan Good who both scored over 300 runs in the season.

Rob Owens and Phil Harrington steered the 4th XI ship through testing times, often hampered by availability throughout the season, fielding 34 players across all their fixtures. The side gave the opportunity for a number of young players to come through from their youth cricket, and it was wonderful to see 3 generations of Harringtons playing in the same fixture!

This year saw our U19 team, managed by Dave Ricketts, play in a cup competition. It was great to see so many of youngsters playing together in the same side, and this bodes well for the future.

Our youth section goes from strength to strength, with the numbers swelling year on year. We have more players, more teams and more fixtures than ever before, and that means more coaches and helpers. With almost 15 teams across all the age groups this is likely to increase to nearly 20 teams in 2020. We hosted our first girls tournament, and we will have at least 2 dedicated girls team next year, which

is a very exciting moment for the club as a whole. We have dozens of players representing the county, and a handful in the Wales Performance Programme, which we hope will increase in years to come.

Our All Stars programme is the largest in Wales, which offers younger players from 3 years old the opportunity to play cricket. We had over 130 boys and girls sign up to the programme, and again, this is likely to increase next year.

It is delightful to see the continued progress of Kiran Carlson and Prem Sisodiya representing Glamorgan throughout the year, and we wish them both well as they establish themselves at the county.

Sadly, we say goodbye to James Lewis, who has been the mainstay of our 1st XI bowling attack over the last 5 years or so. James played his first game for the club in 2008, and has taken over 200 wickets in that time; he has always been very popular at the club, and we wish him well on his life in London.

Congratulations to Mathew Phillips who has been selected for the Wales Over 50 team, playing in the World Cup in South Africa next Easter. Good luck Matt.

As our numbers continue to swell, we saw almost 350 players of all ages at Cardiff CC this season, from our youngest All Star (aged 3) through to our oldest senior player (aged 70). Fridays nights at the club are a joy, if a little hectic, where we regularly see over 200 families at the club, enjoying cricket and soaking up the sunshine.

As ever, the club is indebted to the tireless work of a number of individuals, who quite simply, the club would not function without.
