

Harriett Davies – We are all here as we are interested in Cardiff Rugby. Whether it's the Blues or Cardiff RFC, we all want to see rugby continue at Cardiff Arms Park.

Rugby should be like a tree, with a huge base, a branch for rugby, a branch for the Blues, a branch for members and supporters. This must be surrounded by trust. A lot of Cardiff Rugby supporters feel as though they have been mistreated, there is too much mistrust, especially with money.

Last year there was a meeting with the Cardiff Rugby supporters whereby we conveyed our feeling to the committee in that we just want things to be sorted and finalised. We are here a year later and nothing has happened.

I feel that we need to get this rectified. We need a small team of people to sit at a table with no agenda but to get this situation resolved. They need to have nothing but integrity and a passion for rugby. We need to resolve this situation through arbitration to get what is best for this Club.

Is it, can it be possible to come up with a resolution to keep Cardiff Rugby at Cardiff Arms Park. Is arbitration possible?

Jon Rees – We are not at that stage yet.

Peter Castree – Can I ask why we are not at that stage, a year has gone past and there has been no progress. As far as I am concerned the people on the top table have done nothing.

Jon Rees – We have been negotiating with them for the last 12 months and we have not been able to come up with a solution that we deem to be correct for the members of the Athletic Club.

Fred Davies – Why would Cardiff Athletic Club want to enter into an arrangement with an organisation that is virtually bankrupt, has breached the conditions of their lease, they have not paid the rent.

Jon Rees – the Management Committee are very lucky to have 2 highly regarded professionals who have been leading the negotiations. Would the meeting like to hear from them what exactly has been happening over the last year.

The meeting agreed

David Herbert – We all share the same frustrations with the members of the Athletic Club, in that we have not been able to complete a successful transaction with Cardiff Blues.

I would like to give you a summary of where we have made progress and where we have not.

We reported to the meeting last year that we were very close to completing and heads of terms and we had instructed solicitors to prepare documentation. We were 85% of the way through a legal structure and complex set of documentation. We then discovered that Cardiff Blues were considering handing of the rugby side of the business to the WRU. Not unreasonably members of the committee then questioned who we were dealing with, was it the WRU or Cardiff Blues? We asked for a period of reflection which we took over the course of last summer. The rugby section was more concerned about playing rugby, heritage and operational issues. The reflection from them was strong.

We then had a proposal for a joint venture which contained very little detail and no financial information. The Management Committee were uncomfortable with this as it would see the Club enter into significant construction contracts, and it would also expose the Club to professional rugby, which is currently not profitable. We concluded that some sections were better off not getting involved with that, however the rugby section did want to explore it further. We had our solicitors look at a way in which this club could be restructured. We look at if, or how the rugby section could leave the Club, to enter into a joint venture with Cardiff Blues.

We did not come to a conclusion on that as the issues of heritage and legal stance were very complex. However as it was not concluded it is a possibility that we could go back and consider this at a later date if that is what the rugby section want to do.

We then had a request for a meeting which was to be held on 05-02-18 which would have involved all of the Management Committee & the Blues Board. We agreed to the meeting on the basis that 6 months of rent be paid by 26-01-18. That did not happen and the meeting was cancelled. From that we have all seen the press announcement that they are ceasing all negotiations and are looking at alternative sites.

The Management Committee has much regret for their decision as we all feel that the future of their rugby should be at Cardiff Arms Park, and hope that there will be future discussions. However, it is clear that their current focus will be elsewhere while they consider other options that they are given by the city council.

I would like to assure that this Management Committee has done everything possible to come to an agreement with Cardiff Blues, and we hope that with the benefit of more time we hope that this can happen

Chris Sutton –In 2008 when the Blues were at Leckwith we looked at what the site and appraised it for both parties were to start putting together a new lease. At that time no consensus was achieved.

Again in 2013 we had discussions with the WRU looking at where we have joint issues in sharing a stand. Those discussions rightly came to an end in 2015 when there was a discussion about the RSA agreement, and the Blues rightly said that they would not like the WRU as their landlord if they became a rogue region.

The current discussions started about 2 years ago we got to a stage where we had a heads of terms agreement. We were going to give them an option for 3 years which would have given them time to go and explore the planning, to look at the cost of development etc. They would make option payments during that time but that would have allowed them, at some point in those three years to trigger the option and enter into a new ground lease with a premium payment up front and then annual rent thereafter. The annual rent is really important to the Athletic Club as it has another 4 sections that are looking for a sustainable steady income source. The fact the rent is not currently being paid for this Club is really difficult, we may survive 6/12 months without rent but there will be a critical point where that will affect tennis courts and bowling greens.

There is an option required, a new lease agreements, and cooperation agreement, a ground sharing agreement, there has to be a surrender of the existing lease, and there was also the heritage agreement. On the corporate side there were the shareholders to consider in the corporate agreement. This is a highly complex situation. As an Athletic Club we have incurred many thousands of pounds of legal expenses. We have managed to get an agreement from the Blues that they would be responsible for the first £17500 of our costs. What that means is that they need to give an undertaking to bare our costs, which comes from their solicitor. It has been reported in the press that it's been paid but I can't give you an assurance that it has. (We know that some of it has been paid but know that there are some outstanding monies to be recovered) Our

total legal fees are actually double that, and we have so far paid about £20k of our own legal fees. At the moment we are currently minus £100k on the rent and minus £20k in legal costs. We are fortunate that my time is for free as is David's time. (As is the whole of the Management Committee)

We were 85% of the way there and then we were hit with the fact that the Blues were about to hand the pro team to the control of the WRU. Think about the logic of this, this ground is a very valuable asset and we are fortunate to own this asset. There is a store of value in this asset. That store of value can do one of 3 things; it can pay for the redevelopment of the ground, or it could pay of the debts of the Blues. It could even do both. But effectively that is the choice that we have as the guardians of this ground, is to say where do you want to see that value go to? Bear in mind that when the Blues say that they are going to and the pro team back to the WRU, who are we dealing with? Then it would be a company that does not run a pro team but does run a premiership side in that scenario.

Are we right to sell this asset to a shelf company to do a development for the purpose of something other than the longterm development rugby on this ground.

In addition the rugby committee also had significant concerns with the Blues at that time and as a result it all fell apart last summer.

I attended the board meeting of Cardiff Blues on Monday this week as one of your 3 nominated Cardiff Athletic Club directors. I expressed my opinion that the round of discussion has probably come to an end, and the way forward now would be to look at the future and to define what we are trying to achieve. To look for a vision of what we wanted to create and work back from there. That is when Peter Thomas stated that it was his decision, and he then pulled out of all discussions stating they were going to explore other options that had been put forward by the council.

There is an element that has come to fruition, and there is a reason for me saying that we need to find a new way forward. The RSA comes to an end in 2020. They will make a decision on the RSA probably 12 months before. So if we are to do a deal with the Blues, we should probably need to know that they are going to have a franchise for the pro team in the medium term. It will take a lot of time and money to put a deal back together, and we need to know that post 2020 we will have the Blues here anyway. That is not our decision, this decision is made by the WRU.

This is the background to where we are now, we have spent a huge amount of time and effort trying to make it work, but have not been successful in this case. We will give it another go, but let me be very clear. On Monday in the Cardiff Blues Board meeting, the unilateral decision from the Cardiff Blues Board was that they did not want to take it forward any further.

Jon Rees - Thank you David & Chris. I would like to say at his point that Cardiff

Blues is a professional operation, and their directors are paid to do that job. David & Chris both have full time jobs and families, and the amount of effort that they have put in this year has been phenomenal. The amount of effort that has been put in this year has been off the scale.

Harriett Davies – Would it be fair to say that 15% is the amount of opposition that you have to agree on?

Chris Sutton – In terms of the previous heads of terms we were very close. There was not necessarily any conflict there, it was just that we have not drilled down into the detail. However what I would say to you now is that was when there were 3 years to go to the RSA, now there are only 2 years left. Would you now want to bring in that as a condition from our side?

Harriet Davies – I would say to the Blues, as we know they really don't want to leave, if you pay us what you owe us, we could then sit across the table equally, let work on this remaining 15% of detail and lets get this sorted.

Jon Rees – That is a very fair point. The issue of money is very critical at the moment. As you can see from the accounts the turnover of the Athletic Club is only £217k, we are currently owed over £100k which I am sure you are aware is 50% of our turnover. I am sure that if this was your business you would not accept one of your customers owing you 50% of your annual turnover.

Harriett Davies – I really feel that you need to encourage them to pay up and get back to the negotiating table.

John Summers – As a Club do we really want to get into an arrangement with a business that is untrustworthy and virtually bankrupt? I think that we should let them go their own way and the Athletic Club would be better off with the money from the car park and ancillary facility rents.

Do we want to business with them?

Jon Rees – There will not be anything done until all outstanding debts have been settled.

Peter Castree - Why are the press only reporting the Blues point of view? Why are we not releasing out own statements to the press. I only read the Echo and have seen nothing in there.

Jon Rees – I gave a statement to the BBC which appeared on their website. The same statement appeared on Wales online. We cannot be accountable for what the local papers choose to print in their papers, but the statement was given, and was published.

Peter Castree – As a committee I am suggesting that you make sure that the press and the media get the correct information.

Jon Rees – I have made a statement to the press, and we do not wish our negotiations to be made through the press. We will communicate to our members through channels that we consider to be appropriate.

Keith Morgan – I think that we have been more than tolerant, I was Chairman for 10 years and spent as least 2 days a week chasing outstanding debt from the Blues. They made a statement today that due to cash flow problems they are sometimes in arrears. I cannot remember a time when they have been up to date. This is not a short term cash flow problem, we have asked them repeatedly to pay their debts and they simply shrug their shoulders. This cannot go on any more. It came to a head when the only hold we had over them was to not attend their meeting until they were up to date, and not a single penny was paid and I think that says it all.

Fred Davies – Has forfeiture of the lease been considered? Not only are they not paying their rent, it seems that they are reneging on their repairing responsibilities.

Jon Rees - this has been discussed at our Management Committee meetings.

Peter Ellison – As they are overdue with the rent, why can't we stop them playing here? What is our recourse?

Chris Sutton – Just to give you some background, we granted them a 25 year lease from 1997 – 2022 and the rent originally was £75k per annum, it rises every year by RPI so it is now in the region of £130kp.a. That was a mistake, because the prospectus that was given out to the members in 1997 said that the rent would be £75k per year and would rise by 5 yearly rent reviews on the open market rental value. Subsequently, stadiums like this; Newcastle for example are paying £300k per year. Arguably the rent should have increased more significantly than it has. The car parking income peaked at £700k pa but it has fallen away as has car parking income across the city. There is a significant profit rent for the company. When I joined the committee in 2004 we identified the issue with the rent review clause, but ultimately we were not able to change what has been do to this very subtle change. So the rent has gone from £75k to £135k where as it could have gone from £75 to £200k - £250k. The lease comes to an end in 2022, it is a business tenancy, which means that they have the right to renew the lease on terms to be agrees, which would be the open market rental value, and for same term that already existed. However we as landlords, as long as we have owned it for more than 5 years prior to the expiry of the lease, we can oppose the granting of the lease on 7 grounds. Those grounds include wanting it for our own occupation, we could want it for redevelopment, we could oppose it on the grounds of poor payment of rent, we could oppose it on the grounds of poor repair. We are in a position to be able to oppose granting them a new lease, however we would be obliged to give them

compensation. The compensation, as it is a lease of more than 14 years, we would need to pay them 2 times the rateable value, which is about £200k.

So in 2022 we could take this lease back ourselves, we could run this ground for our own purposes if we wanted to. You mentioned forfeiture, we would not necessarily to straight to forfeiture, but we would get the bailiffs in and we could serve a winding up order and get the arrears paid. However there is a grey area in 2020 – 2022, because if the WRU does not renew the Blues franchise, they do not have a team to play here anyway. This is an interesting situation that it is really not far away until we will know the outcome and we can look at other options.

David Herbert – I would just like to add to this, in the press today, the Cardiff Blues Chief Exec Richard Holland was talking about the £8 million indicating that this was an unconditional offer to Cardiff Athletic Club, but this is not the case. He secondly asserted that the legal fees had been paid by Cardiff Blues. We know that there are some monies outstanding.

Just to finish off about the commercial agreements, these are largely in place, the really difficult area to agree on were the rugby operation and heritage areas.

Chris Norman – When we attended the meeting last year with the Management Committee and Blues committee, and they dropped the bomb that they were planning on giving control of the pro team to the WRU, and then within 5 minutes decided that they we not, and our deal was back on we were obviously quite stunned.

The fact they were going to discuss an option agreement.

The option allows another entity to take our lease. This obviously concerned us they even if we had done the deal last year, under this option agreement someone else could become our tenant. With regard to the rugby section, we are all too aware of what has happened at Rodney Parade. What we are responsible for as a rugby committee, is to make sure we do not lose Cardiff Arms Park. We appreciate the fact that commercially most of the agreement was complete, but we did not feel that we were able to trust them to protect Cardiff RFC. This mistrust grew further when I met Martyn Ryan at the premiership meeting on 18th May, and he apologised for Peter Thomas' comments at the Blues AGM. I explained to his that we were afraid that if the deal went ahead, Peter would sell it onto "A Another" and we have lost Cardiff Arms Park for 150 years. That is when I opposed discussions and looked at the possibility of a joint venture, and through a joint venture at least we would remain the guardians of Cardiff Arms Park. Martyn Ryan contacted me to say that he had spoken to Peter Thomas and John Smart and they were interested in talking further. So over the next few months we looked at seeing how we could guarantee Cardiff Rugby, both the Blues and RFC remain at Cardiff Arms Park. We have spent so many rugby hours trying to resolve this.

All of this has been complicated by the RSA agreement as we cannot be sure of what the WRU are going to announce.

However we persevered, and, we got to a position where by we constructed a discussion document to demonstrate where our passion is, we took that document to present to the Blues Board on Monday, they did not even have the courtesy to read it and then they announced that all discussions were off and they we going to look for an alternative venue. As far as the rugby committee is concerned, we are trying to make it work for rugby while being mindful of what the commercial agreements had been set in place. We are not going to give up, we hope that they come back to the table, but if this does not happen it won't be from lack of effort from our Rugby and Management committees.

Darren Jones –I would like to ask, if it does all fall apart and Cardiff Blues do walk away, what is your vision for rugby at Cardiff Arms Park?

Chris Sutton – Although I do not have any authority to say this, this is from me, This is an iconic rugby ground in the centre of our capital city. I love Cardiff and I am really passionate about our city and I think that this is a great stadium. It has so much history and heritage here. I think what we have to do is plan for the worst and happens for with the Blues then so be it. We have a lease which expires in 2022 and this ground can come back to us. The ground already has a sustainable income stream here from car parking which I worth hundreds of thousands of pounds, I am sure we could do a deal with whoever is the new franchise holder. However there are issues, with the ground due to its age and it needs investment. Parc Y Scarlets cost about £15 million to develop, that was 10 year ago. This would be more, especially given that this is a city centre site. We would need to try and create a vision that gives us the income stream to do that. There is the potential for ancillary development. We would involve the WRU, we have a common issue with our south stand and their north stand, we could get some investment from them to cover some of the costs.

Let's also remember that there are 4 sections of Cardiff Athletic Club who are also looking for an income stream. Hockey remains homeless, they are deserving of capital investment. We have to recognise that other sections have needs.

We have not really talked about the Athletic Clubs other successes, but we have built 2 new tennis courts for Lisvane Tennis Club, and we have invested in our other sections also.

To reiterate, we plan for the worst and hope for the best.

GarethMoore - Give that Cardiff RFC and Cardiff Blues are so intrinsically linked, if they left, would they take Cardiff RFC with them?

Brian Bennett – CAC gave up rugby in 1997, currently Cardiff RFC and Cardiff Blues are both run by Cardiff Blues ltd. In 2022 the title of Cardiff RFC will revert to Cardiff Athletic Club. I think that we could easily take over the running of that team, and I think that they would be happy to hand it back.

As a trustee I am concerned about granting a 150 year lease to a company that is £14 million in debt of director's loans. When the negotiations first commenced, it was evident that the directors we primarily concerned in getting their money back.

David Allen – One of the other comments the press this week is that Cardiff Blues had agreed to protect the Cardiff Name. Whilst it has been agreed to protect the name of Cardiff RFC, there is not real agreement to keep Cardiff in the Cardiff Blues brand. I believe that they want to keep it in principle, but is subject to the WRU agreeing it. The view from the Cardiff Blues Board is that the name Cardiff is theirs to give away, but as supporters we do not think that it is.

Harriett Davies – Has anyone actually asked the WRU if it is ok for Cardiff Blues to keep the name Cardiff? If they knew that this was a huge stumbling block, could we not just ask them the question?

Jon Rees - Point noted.

Tim Gould – it seems clear that we have here a tripartite discussion. Here is the WRU, and Cardiff Blues. Both organisations have the benefit of being professional, they also have more time to dedicate to negotiations. It does feel like we are an amateur Athletic Club trying to negotiate with professional negotiators, and we are coming off worse. That will continue until we either go "nuclear" and keep them out, or take it back over in 4 years time. At the moment it does not seem that we can negotiate any further.

Jon Rees – I take your points, other than the fact that we coming off worse because we are amateurs. If we had not given them so much resistance we could have ended up with a deal that would not have been any good for the Athletic Club. The fact that we have stopped meeting with them until the rent has been paid it actually showing them who are the professionals here.

Tim Gould – I meant no disrespect. However we have been negotiating for 10 years and we keep hearing phrases like let's take some time, and we are no closer to reaching any agreement.

Jon Rees – Wouldn't you rather have no agreement than the wrong agreement?

Tim Gould – this is what I was trying to ask you, what do you think?

Jon Rees – I would rather have no deal than the wrong deal.

Tony Nash –A lot of the members concerns have come from lack of information, going forward, would it be possible to share the minutes of your meetings?

Jon Rees – That is a very good point and I will discuss this with the committee, but my personal view is that we will publish a condensed version on the Cardiff Athletic Club website. I think this will make the club far stronger as there will be no mis-information

Jeremy Sparkes – Last year I asked a question about the constitution and if it could be changed to include a proxy vote. I would like to get the feeling from the meeting, if we would like the committee to address the way members can use their vote, if they are not able to attend meetings. It would be a shame for members to feel disenfranchised, if they are unable to attend due their commitments.

Jon Rees – That would involve a change in the constitution, which I think we would have to refer it to our solicitors to look. I shall add it to the agenda for the next Management Meeting.

With no more questions the Chairman, Jon Rees closed the meeting at 20:04.

David O Herbert had served on the Management Committee for several years, in various roles and his wise council will be greatly missed. Brian Mark had served the Club as a player, Committee man and Vice President, and supported Cardiff Rugby Football Club until his passing. Please accept my apologies if there are any omissions.

I assumed the role of Chairman after Jon Rees decided to step down from the role due to increasing pressure of an expanding and successful business. Our thanks to Jon for his sterling work during his two years as Chairman and wish him every success in the future. I am pleased to report that Jon will continue to represent the Cricket section on the Management Committee.

There have been some well reported discussions regarding the ground improvement and granting of the leases but despite the efforts of the Management Committee we were unable to agree any deals, but continue to discuss matters with interested parties. We appreciate that this is frustrating for our members who perceive this as a lack of information but the Management Committee consider that we should only report on firm developments and not speculation out of respect for the other parties involved.

As can be seen from the sectional reports, the promotion of sport, particularly the development of young talent has continued to flourish and our thanks go to all involved in the coaching and administration of these sections.

Thanks to all members of the Management Committee for their support and for devoting an increasing amount of their time attending meetings sub-committee discussions. Particular thanks to David Herbert and Chris Sutton who have continued to give their time and expertise to Cardiff Athletic Club without any form of financial reward.

Thanks to Karl and the team for looking after our clubhouse and keeping the business going through some difficult times and I urge all our members to use the club as much as possible.

Last, but certainly not least, my thanks to Abbie for not only looking after the day to day issues at CAC, but also going beyond the normal duties when required to solve more difficult issues.

Opinion

We have audited the financial statements of Cardiff Athletic Club for the year ended 31 May 2018 which comprise the Income and Expenditure Account, the Balance Sheet and the related notes. 1. Statutory information

Cardiff Athletic Club is governed by the Club Rules. The Club operates from Cardiff Arms Park, Westgate Street, Cardiff, CF10 1JA.

The financial statements are presented in Sterling (\mathfrak{L}) which is the functional currency of the Club and rounded to the nearest pound.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

2. Basis of accounting

These financial statements have been prepared in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland". The financial statements have been prepared under the historical cost convention as modified by the revaluation of certain assets. There have been no material departures from Financial Reporting Standard 102 1A.

Income

Income is accounted for on a receivable basis.

Fixed assets

Freehold land and buildings, and other tangible fixed assets are stated at cost, less accumulated depreciation where applicable.

Heritage assets

Heritage assets are held principally for their contribution to historic knowledge and culture. Assets are measured initially at either their cost, or valuation if donated, subject to any depreciation or impairment. Where information on cost or valuation is not available and can not be obtained at a cost commensurate with the benefit to the users the assets are not recognised.

Expenditure incurred to preserve or prevent further deterioration of the collection is recognised as it is incurred.

Investments

Investments are recognised initially at fair value which is normally the transaction price excluding transaction costs. Subsequently, they are measured at fair value through profit or loss if the investments are publicly traded or their fair value can otherwise be measured reliably. Other investments are measured at cost less impairment.

CARDIFF ATHLETIC CLUB NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MAY 2018

Depreciation

Depreciation is provided at the following rates;

Straight line basis on fixtures / ground equipment, office furniture / equipment, tennis court / equipment at a rate of 25% per annum.

Straight line basis over the term of the lease in respect of land and buildings – leasehold.

No depreciation has been provided on freehold land and buildings. The Cardiff Arms Park is let under a full repairing lease and has to be maintained in accordance with Sports Ground Legislation, such that the value does not diminish over time. The Management Committee are of the opinion that the market value of the land is greater than the value at which the land and buildings appear in the accounts. As a result, the corresponding depreciation would not be material and therefore is not charged in the Income and Expenditure Account. The Freehold Property at Lisvane is newly built and is subject to a maintenance period.

The Management Committee perform an annual impairment review in accordance with the requirements of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland" to ensure that the recoverable amount is not lower than the carrying value.

Current tax

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date. Current tax liabilities are not discounted.

Debtors and creditors receivable/payable within one year

Debtors and creditors with no stated interest rate and receivable or payable within one year are recorded at transaction price.

Grants received

Grant received in respect of capital expenditure are treated as deferred income and are credited to the profit and loss account over the useful life of the asset to which they relate to.

Loans

Cardiff Athletic Club received a loan to assist with the financing of the expansion of Lisvane Tennis Courts. This loan has no interest attached to it and is not secured. The loan is repayable in 6 monthly instalments over a 10 year period.

CARDIFF CRICKET CLUB CHAIRMAN'S REPORT 2018

2018 was another positive season for the club although we could not repeat the success of the previous year.

The first team experienced a season of transition after losing some players who were key performers in our 2017 success. We relied on young players who have progressed through our junior system. These players had to step up to 1st team cricket and with the guidance of the senior players we were able to finish 3rd in the league and reach the semi-final of the Welsh cup.

Stand out performances of the season include bowlers Tegid Phillips who at 16 took 29 wickets in the league and cup, with best figures of 7-38; and Osama Subhan who took 20 wickets in his first season opening the bowling. In addition we will be trying hard to launch a girls and women's section of the club to offer opportunities to as many players as possible.

We continue to have frustrations with availability below the first team and we need to offer our captains more support in this regard. CARDIFF RFC CLUB CHAIRMAN'S REPORT END OF SEASON REPORT 2017 / 18

Whilst writing the chairman's report, it was announced by Cardiff Blues that Peter Thomas was stepping down as chairman of the region in forthcoming year. He willhandover the reins to a new chairman in readiness for season 2019/20. Peter will remain as a major shareholder of the board and also take his position of Life President. Peter's contribution to Cardiff Rugby has been colossal, without his financial backing there would be a strong possibility that professional rugby in Cardiff would not exist. We owe him a great debt of gratitude for his services to Cardiff and wish him well in the future.

With a clear involvement from WRU, they have recognised the need to support the Region not only with extra finance but clear guidelines on the governance of the board. There will be an appointment of three non executive directors and continued dialogue on how the Blues can expand on its position of being based in the capital city.

Cardiff Blues season ended successfully, reaching the position of fourth in Conference A, which gains them a Champions Cup entry next season.

Obviously the winning of the European Challenge Cup against Gloucester in Bilbao was a tremendous victory, coming back from a half time deficit of 20-6. The sheer determination of the players in the second half was legendary, with Ellis Jenkins and Gareth Anscombe inspirational.

The sad loss of coaches Danny Wilson & Matt Sherratt to Scotland & Ospreys respectively, we certainly wish them well in their new positions.

Congratulations and welcome to new head coach John Mulvihill on signing a three year deal, building on Danny Wilson's legacy.

Also good luck to new staff members Jason Strange and Tom Smith, together with Duane Goodfield and Richard Hodges on the completion of 1st team coaching group. Cardiff RFC season ended disappointedly, with a final position of 8th in the 16 team premiership league. However there were strong periods where the team were in the top three but the injury count was surreal, with many first team players unavailable in the last three months of the competition, notably the loss of our captain Joe Tomlinson, so early in the season. However the 5 game winning run was the highlight especially the victory at Carmarthen Quins 34-10

With the advent of A team/under 23 rugby next year, we have the benefit of head coach Steve Law having more players at his disposal. It has been recognised that there will only be ten fixtures or so, leaving many players without rugby during the season.

The premiership in season 2018/19 will remain (at present), East/West divisions of 8 teams, will secure 29 games including a host of local derby's, with the added excitement of the importance of every game, as 4 teams will be relegated and the bottom fifth team will have a play off with the winners of the Championship.

Congratulations on the following players receiving their caps, namely LlywarchApMyrddin, Ian Jenkins, Will Rees Hole, Ben White, Frazer Young, Peter Lloyd & Rhodri Cole.

Gareth Thompson was top point's scorer with 242 points a gain of forty from his last years total. Will Rees Hole was top try scorer with 15 tries.

The player with most appearances was Luke Crocker (Flanker), who played in

29 games, who also gained the player of the year Award. The most promising player of the year was awarded to Peter Lloyd (Prop), whilst playing under permit from Glamorgan Wanderers; he played like a seasoned pro in this year's premiership.
