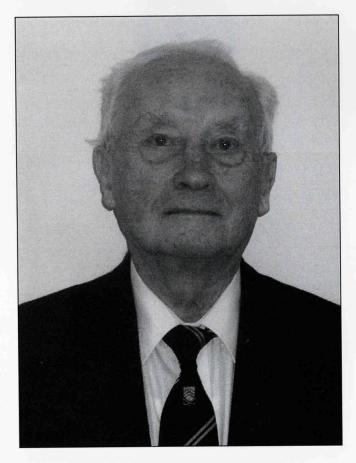

Under the current lease it is unclear where some of the liabilities for the Ground lie. "Glanmors Gap" rumours rumoured to have a life existence of 6 months to 20 years. At some point CAC Management will have to deal with this if this area starts to fail.

David Herbert – No. We will have to work in the details of the legal perimeters of the lease, but we will endure ensure that the whole freehold remains with Cardiff Athletic Club.

Written question from Paul Brewer; In the light of the current lease negotiations with Cardiff Blues, I would like to know if CAC is considering as an alternative, then forming a company independently in order run the regional franchise. If not they why not? As the freeholders we are in a strong position to attract the investment during the remaining 7 years of the current leasehold agreement. This would then safeguard the heritage of CRFC as well as gaining back control of the playing sides, to the benefit of all sections.

Jon Rees - This is not going to happen as the Cardiff Blues franchise owned by a separate limited company. At the moment this cannot be done.

Written question from Phillip Thomas; Have the lease negotiations included the option of the team branded Cardiff RFC being returned to Cardiff Athletic Club ownership from Cardiff Blues Ltd, and if so, under what mandate does the CAC Estates Sub Committee either agree or refuse the option without going to the Members?

Jon Rees – It has been neither agreed or refused but does form part of the ongoing negotiations.

Richard Hudson –Looking at the acting Rugby Chairman's report from last season – it states "Last season was disappointing in terms of our final league position of ninth. The lack of consistency in the availability of players for selection and the fact that these

players were only able to attend one training session per week contributed hugely to our lowly position." We are still in 9th place, are there any reason that are different this year?

Chris Norman -In the autumn of last year, we were given a presentation by the Cardiff Blues academy coach, who went onto become the Cardiff RFC senior coach Duane Goodfield, to say that we would have more players available. We had 9 or 10 Blues players available for the first 4 games of the season and then the following month we didn't have any available at all. Effectively, we had too many players at the start and not enough at other times. The presentation that Duane gave us a week ago indicated that the model that was presented did not work. The idea going forward is 5 Blues blues players appointed to us for the season, and with the stronger Cardiiff RFC team that we are building, we feel that we have a better chance of doing well going forward.

Ray Smith – Can you explain to me why the bottom 8 of the league are affiliated to a region, whist the ones above are not.

Chris Norman – In my personal opinion, those that have supported regional rugby are the Swansea, Bridgend's and the Llanelli's of this world. We are seen by the regions as part of their teams. We are seen as their training team, for try out for their new talent and to bring new players through the system. Whereas Bedwas, Camarthen and Merthyr, they are stand alone, and you are right, the league seems to be upside down. Going forward we are working with the Blues on a co-operation agreement. It is with regard to strengthening the situation with ourselves and the Blues, and I know that we are not the only club having that conversation. The great thing about the new co-operation agreement is we know that Cardiff RFC is very high on their agenda.

Jon Rees – I would like to remind the members that this is Cardiff Athletic Club AGM and we can not get into too much detail of the playing sections.

Ray Smith – the reason I have raised this is that Peter Thomas has said in the press that the Blues run Cardiff RFC and the committee has no say in how its run. Cardiff Blues are dragging us down all of the time, its been too long since we have had a good Cardiff RFC side.

Jon Rees – at this present time Cardiff RFC is under the control of Cardiff Blues.

Stephen Parker – As part of the lease negotiations, could you look towards pulling Cardiff RFC back into the control of Cardiff Athletic Club?

Jon Rees – as part of the new co-operation agreement, I would suggest that the Rugby Committee will want more involvement. The co-operation agreement will not be signed without the full agreement of the Rugby Committee.

Stephen Parker – Cardiff Blues treat Cardiff RFC with contempt. We need to break away from them or we will continue to be a bottom placed team every season.

Jon Rees – if that is the mandate that the Rugby section makes, then that is the mandate that the Rugby section should bring to the negotiations. You will need to speak to your own Committee to do that.

Stephen Parker – can you confirm the opening hours of the Club House.

Jon Rees – It is open from 11am – 11pm every day apart from Sunday, Monday and Tuesday.

Stephen Parker – Why are they shutting the gates at $10.30 \,\mathrm{pm}$ when people are still in the bar.

Jon Rees – I will raise this issue with Jamie Muir.

Clive Davies – there has been no water in the men's toilets hand basin for over 2 months, and the boiler in the Jack Matthews bar has been broken for months

Jon Rees – Please raise this at Management Committee and we can deal with this there.

Jeremy Smart – I am curious to know why there is no Cricket section report in the AGM booklet

Jon Rees – It has been reprinted and its available.

David Allen – Last year we had a briefing note on the negotiations of the lease and where we were up to. We have not had anything this year.

Chris Sutton – I am a member of the Management Committee, I am a chartered surveyor and alongside David RJ Herbert who is a member of the Management Committee and another chartered surveyor working in Cardiff, we are instructed by the Chairman and Management Committee to advise on these negotiations, but we make no formal decisions. We report back to the Chairman and the Management Committee. In December 2015 we gave you an update, and we then entered into a further round of discussions with Cardiff Blues. In February we had a detailed meeting and here the goal posts changed a little from Cardiff Blues, and it took a few months to bring that back to what was acceptable, for us to recommend to the Management Committee. In October last year we agreed what we called a Memorandum of Understanding, which was a 6 page document, this is a detailed heads of terms agreement. This received the backing of the Management Committee subject to CAC members giving formal and final approval at an EGM followed by final approval of the Trustees. Discussions have been ongoing in the background. The negotiations are subject to a triple lock approval, that is approval from the Management Committee, approval from the Members at an EGM, and approval of the Trustees who have a duty under their trustees arrangements. We have provisionally agreed to these terms and have instructed solicitors to prepare documents along the lines of the briefing note that we given a year ago. When we have an agreement on the draft lease options, we will be in position to issue a notice of an EGM. We are looking to be in a position to call an EGM in roughly 2 months.

We are very conscious of the comments from last year AGM, where by you would require a full briefing in advance, and we will arrange for you a detailed information pack.

David Herbert – the reason for the apparent delay in coming to the members is that we have had stages of 1 step forward and 4 steps back. We are now in a position where everybody is now certain of what everyone has agreed to. We have reached more or the position we were in last year, but with improvement for the members. We will ask the Blues to make a presentation at the EGM. We will give you as much information as they will allow us to give you.

Jill Parker – As part of the pack that you will send out, will you include a copy of the co-operation agreement that Chris (Norman) mentioned earlier.

David Herbert – There are many elements to this. There is a property deal, there is a Corporate deal in relation to shares, and there is also in the crux of everything the ongoing relationship between Cardiff Blues and Cardiff Athletic club in any new facility. We have drafted the documents so there is protection in the cooperation agreement. They will not be able to trigger the option until that agreement is approved with Cardiff Athletic Club and the Blues. There is a further safeguard that the rugby section will be heading up the negotiations on that but we have to get the playing issues that we have talked about and the ongoing organisational issues settled to our satisfaction. This is, potentially, a transformational transaction, we have got to take our time to make sure that it is right.

Chris Sutton – there is a really strong protection point here for the Club, we are looking at creating a new ground lease and that means the Athletic Club remains the freeholder and landlord, and the Landlord / Tenant relationship is a lot stronger than if we put a covenant on the site. We will have a user clause in there that the primary use for this site must remain Rugby. There will be ancillary development in order to pay for the upgrade of the facilities. With the Landlord / Tenant relationship and the creation of the ground lease with a user clause within it, this gives us significant protection. If they do not deliver that that, they will be in breach of their obligation of the lease, and as the Landlord will have more protection, and be able to remedy that.

Jill Parker – referring to your Landlord / Tenant agreement that is in place at the moment, are the tenants actually paying their rent?

Jon Rees - Yes

Fred Davies – Is it correct that they are getting into an arrangement with a Middle Eastern consortium?

Jon Rees – I am not able to comment on that. Full details of any proposals will be circulated to all paid up members at least a month before an EGM.

Ray Smith – Are Cardiff Blues able to sell on the lease to a third party?

Chris Sutton – The lease will still have the requirement to deliver a rugby ground, so this will ensure that there will always be rugby at Cardiff Arms Park.

David Herbert – it is possible that the lease could be assigned or sub-let to a third party, there is only so much control we have over who will be our tenants.

Tony Nash - I am curious how the value of the lease is calculated. Are we getting the best return on the investment for the members? Should we be looking for an alternative tenant / developer to take over the lease?

Chris Sutton – 18 months ago we instructed an independent team of chartered surveyors to provide us with a valuation of the site. That firm was BNP Paribas Real Eatate based in Bristol. They gave us their opinion of value of the existing freehold interest. That figure is significantly below the figures that we have agreed with Cardiff Blues. In terms of going out to the wider market, it is possible we own 7 acres of prime real estate. We could look to develop it to be flats etc, anything apart from large scale retail due to the attitude of the planners towards the site. The Management Committee however are committed to protecting the rugby ground and the heritage of this ground as a rugby facility. We do anticipate some ancillary development of the ground, however, the rugby stadium will be the primary development on this site.

The other point of looking at the wider development, is that we already have a tenant, they are in effect a "special purchaser." We cannot force them out at the moment, so if we were to look for an alternative third party, we could not deliver them vacant possession. That said, in 2022, we could object to the granting of a new lease. They are a protected tenant however, we could object on a number of grounds including redevelopment, concerns regarding the late payment of the rent or even requiring the property for our own use,. There would be an element of compensation, however while that is an option, we do not want to go down that route. In addition, we have to consider if Cardiff Athletic Club has the administration capability to redevelop it ourselves and run this facility.

Brian Bennett – The question that has been posed is also a matter for the Trustees. The Trustees, with the permission of the Management Committee have appointed an independent lawyer to advise us on our responsibilities. There are parts of

the terms of this transaction that will need to be looked at, but essentially we consider this to be the best way forward. We will ensure that all members have the appropriate information prior to an EGM, with all of the arguments for and against. If it is passed and the Trustees are satisfied by their legal requirements, then this is the best way forward.

Jeremy Smart – is there provision within the constitution for members to have a proxy vote at an EGM if they are not able to attend?

Jon Rees – there is no provision for a proxy vote. The minimum notice period for an EGM is 3 weeks, but we would look to give at least 4 weeks to give everyone suitable notice to attend.

Fred Davies - Are you prepared to look at any alternative options or is this the only option available?

Chris Sutton – we have only one proposal and we will put this to the members. We are an amateur Athletic Club, we no not have the finances or capabilities of developing this ourselves. We have one proposal that has been put forward to us by Cardiff Blues and we have negotiated this to a proposal that we can recommend and we shall put this to the members when it is final, to be voted upon.

Name Unknown - Are the members aware that this proposal will remover the bowling club from this site?

Jon Rees – full details of that will be included in the proposal pack we present to the members.

Ben Eaton – if the vote should be a no, what is the strategy going forward?

Jon Rees – this is something we will have to consider after the vote.

Clive Williams – Have the WRU been involved in any of the negotiations? When our south terrace is taken down, their north stand will come down with it.

Chris Sutton – we have had a meeting with Martyn Phillips and Steve Phillips who is the FD of the WRU. We have set out the full terms of the proposal with Cardiff Blues , they are content that we continue with our discussions and made no inclination that they want to get involved.

With regards to the stands, the issue is more so for us than them, as they say their stand has been signed off for another 25 years. From our side, there are now some issues with the concrete in the stand. The current arrangements in terms of the lease at the moment are unsatisfactory. The lease that was drawn up in 1997 was worded in a way that neither party has responsibility. Effectively the tenant has a

full insuring and repairing lease which does not apply to the south stand.

One of the biggest benefits of this Memorandum of Understanding is that we clear up the grey areas of the previous lease and service agreements. Fundamentally if this was to be approved, full responsibility for all repairs and maintenance would fall upon Cardiff Blues.

Tony Tarr - if this development does go ahead, where would Cardiff RFC play their rugby?

Jon Rees – an alternative venue would have to be found for both Cardiff RFC and Cardiff Blues for at least a season.

Jon Rees – as I have stated in my report, as an Athletic Club we should be very grateful for all of the work that Chris Sutton and David RJ Herbert have done to get us this far, it is above and beyond the call of their duties as a Management Committee representative.

Gareth Thomas – The cost of a pint downstairs if 50p-60 more expensive than many of the pubs that we within 2 minutes walking distance, members clubs are usually cheaper than their competition.

Jon Rees – The bar is run by Cardiff Blues. I take your point about your traditional members Club where by the profits are ploughed back into that club, unfortunately that is not the case here

With no more question the Chairman closed the meeting at 19:51.

Unfortunately my annual report again begins by noting the passing of a number of rugby greats, Gareth Griffiths, Lloyd Williams and Graham Davies. In addition to this, Ruth Williams, the widow of the late CD Williams, Albert Francis, our former groundsman and Barrie Williams, bowls section stalwart and Management Committee member also sadly passed away this year.

I apologise for any omissions but our sincere condolences are extended to the family and friends of those that have sadly left us.

With regards to the memberships I am delighted to report that the numbers continue to increase at a healthy rate and certainly in some sections the development of young talent has been particularly noticeable. I extend my sincere thanks and compliments to all concerned for the effort put in to producing our players of the future.

The bowls section had a difficult summer due to disruption caused by the hosting of a number of events at the Millennium Stadium which unfortunately impacted greatly on the ability of the section to host games. The manner in which the section stuck together during this difficult summer bodes well for the future though.

The cricket section continues to flourish under the chairmanship of Robbie Weston. The first team did the league and cup double with Alex Milton and James Lewis being the top league batsman and bowler respectively.

All other sides performed creditably in their leagues with the majority of the players being under the age of 19 which shows the depth of the youth section which now has children as young as 4 attending on a Friday night.

The hockey section continues to perform strongly and only missed out on winning their National Hockey division on goal difference. A strong performance in Europe though has resulted in the first team again qualifying for the European Hockey League.

Special mention must be made of Dan Kyriakides who has been selected for the Great Britain training squad for the Tokyo Olympics.

The rugby section suffered the frustration of missing out narrowly on qualification to Tier 1 which impacted greatly on the regularity of fixtures in the second half of the season.

A strong finish to the season bodes well for 2017/18 and the section continues to provide a valuable pathway to both regional and international rugby.

The tennis section has made great strides since the opening of the two new courts which has resulted in greater participation at all levels.

A particularly notable achievement was the winning of the Club team of the year by the Under 16 team at the 2016 Tennis Wales Awards.

Our Members lounge is open throughout the week from 11am daily and I hope that the members will increase their use of the Clubhouse throughout the week and not just on match days.

We continue to discuss the long term position with Cardiff Blues and over the past year significant progress has been made.

Please be assured that our members will be consulted before any material changes to the existing structure are proposed.

Particular thanks must again go to Chris Sutton, David RJ Herbert and Chris Nott for the enormous amount of time that they have devoted to the ongoing discussions with Cardiff Blues.

My thanks go to all of the Management Committee for their help, guidance and support throughout the year and their tireless efforts on behalf of their respective sections.

Abbie Gibbins continues to be a tower of strength on the administration side of the business and I thank her for her continuing efforts which regularly exceed the level that she is paid for.

To Spiro, Karl and staff I wish many thanks for their hospitality and great service in looking after the members.

Last but certainly not least I thank all the Members of Cardiff Athletic Club for their support throughout the year.

INDEPENDENT REPORT OF THE AUDITORS TO THE MEMBERS OF CARDIFF ATHLETIC CLUB

We have audited the financial statements of Cardiff Athletic Club for the year ended 31 May 2017 which comprise the Income and Expenditure Account, the Balance Sheet and the related notes. The financial reporting framework that has been applied in their preparation is United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), including Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland".

This report is made solely to the club's members, as a body. Our audit work has been undertaken so that we might state to the club's members those matters we are required to state to them in an auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the club and the club's members as a body, for our audit work, for this report, or for the opinions we have formed.

Respective responsibilities of Committee of Management and auditor

As explained more fully in the Committee of Management's Responsibilities Statement, the Committee of Management is responsible for the preparation of the financial statements which give a true and fair view. Our responsibility is to audit and express an opinion on the financial statements in accordance with International Standards on Auditing (UK and Ireland). Those standards require us to comply with the Auditing Practices Board's (APB's) Ethical Standards for Auditors.

Scope of the audit of the financial statements

An audit involves obtaining evidence about the amounts and disclosures in the financial statements sufficient to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or error. This includes an assessment of: whether the accounting policies are appropriate to the club's circumstances and have been consistently applied and adequately disclosed; the reasonableness of significant accounting estimates made by the Committee of Management; and the overall presentation of the financial statements. 1. Statutory information

Cardiff Athletic Club is governed by the Club Rules. The Club operates from Cardiff Arms Park, Westgate Street, Cardiff, CF10 1JA.

The financial statements are presented in Sterling (£) which is the functional currency of the Club and rounded to the nearest pound.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

2. Basis of accounting

These financial statements have been prepared in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland". The financial statements have been prepared under the historical cost convention as modified by the revaluation of certain assets.

There have been no material departures from Financial Reporting Standard 102 1A.

These financial statements for the year ended 31 May 2017 are the first financial statements that comply with Financial Reporting Standard 102 1A. The date of transition is 1 June 2015.

The transition to Financial Reporting Standard 102 1A has resulted in a change to the accounting policy for investments. There has been no change or impact on opening funds.

Income

Income is accounted for on a receivable basis.

Fixed assets

Freehold land and buildings, and other tangible fixed assets are stated at cost, less accumulated depreciation where applicable.

Investments

Investments are recognised initially at fair value which is normally the transaction price excluding transaction costs. Subsequently, they are measured at fair value through profit or loss if the investments are publicly traded or their fair value can otherwise be measured reliably. Other investments are measured at cost less impairment.

CARDIFF ATHLETIC CLUB NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MAY 2017

Depreciation

Depreciation is provided on a straight line basis on fixtures / ground equipment, office furniture / equipment, tennis court / equipment at a rate of 25% per annum.

No depreciation has been provided on freehold or long leasehold land and buildings. The Cardiff Arms Park is let under a full repairing lease and has to be maintained in accordance with Sports Ground Legislation, such that the value does not diminish over time. The Management Committee are of the opinion that the market value of the land is greater than the value at which the land and buildings appear in the accounts. As a result, the corresponding depreciation would not be material and therefore is not charged in the Income and Expenditure Account. The Freehold Property at Lisvane is newly built and is subject to a maintenance period.

The Management Committee perform an annual impairment review in accordance with the requirements of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland" to ensure that the recoverable amount is not lower than the carrying value.

Current tax

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date. Current tax liabilities are not discounted.

Debtors and creditors receivable/payable within one year

Debtors and creditors with no stated interest rate and receivable or payable within one year are recorded at transaction price.

2. Basis of accounting

Grants received

Grant received in respect of capital expenditure are treated as deferred income and are credited to the profit and loss account over the useful life of the asset to which they relate to.

Loans

Cardiff Athletic Club received a loan to assist with the financing of the expansion of Lisvane Tennis Courts. This loan has no interest attached to it and is not secured. The loan is repayable in 6 monthly instalments over a 10 year period.

CARDIFF ATHLETIC BOWLS CLUB CHAIRMAN'S REPORT 2017

I am beginning my report this year by commenting on matters not directly related with the playing of bowls. The first is the on/off saga of the proposals to develop the Arms Park site and the second is the constant closure of the access to the Bowls Club occasioned by events at the Arms Park and the Millennium Stadium.

During 2016 we were promised full discussions and consultation on the development of the Arms Park site. From my point of view that has never happened, one moment we are told one thing, the next the story has changed. Scheduled meetings with members to explain what is happening have never taken place and information, true or otherwise, seems to come from the media. We are no clearer now as to what is going on than we were in 2016. This is a shameful way to treat members of Cardiff Athletic and it is blighting the future of the bowls section who are unable to plan ahead.

2017 has also seen constant and continuous disruption to our access to the bowling green because of events like the Champions League final and concerts. We now find that access is also prohibited prior to rugby games. We have never been consulted about a programme of closures nor has any thought been given as to access for bowlers and their cars when these events take place. There has been serious disruption to our season and loss of revenue to the bowls section through loss of games. I am sure that large sums of money have been paid for use of the site but no thought has given to compensating the bowls section for the losses we have suffered and we will be pursuing this with the main Committee.

Our season began in April with the opening of the green. We also used the occasion to present the trophies for 2016. The evening was a great success and I must thank the members for their support and Bob Williams, our President, for presenting the trophies.

Despite the very mixed weather we have experienced this season and the disruption to access I mentioned earlier, we have endeavoured to fulfil all our fixtures, some by playing home fixtures away and others by postponing them until later dates. We have tried to field two teams each Saturday and the second team have often played short of players. The first team captained by Martin Summerhayes and, more often than not by Les Hazell as his deputy, had a very difficult season. Early promise in the Curruthers competition winning through to the next stage soon waned and we finished the season on a disappointing note.

The A team under the captaincy of Kevin Bush and Vice Captain Jack Gardner with support from Aaron Sedgemoor did somewhat better finishing mid table in spite of having to play some games short of players. This was a very creditable performance and I congratulate them on their resilience in a difficult season.

The Alliance and Mid Week league also provided some well contested games and I am indebted to David Cox, Martin Summerhayes and Les Hazell for their

captaincy of these teams.

The annual bowls trip to Torquay and Taunton arranged by Dennis Turnbull with support from Alex Rayer was a great success. The weather was very kind to us and the friendship and hospitality provided by the two clubs was exceptional. Although Barrie was being treated for prostate cancer his treatment was going well and he had continued his work with the club and played bowls right up until his untimely death. His passing stunned us all. He was a great servant to the club, serving on the Management Committee, working behind the bar and cutting the green. He was also a member of the Management Cardiff Athletic Committee. Nothing was too much trouble for Barrie and he will be greatly missed by us all.

The Club's Annual Tournaments were again run and completed under the guidance of Martin Summerhayes. Congratulations to Les Hazell on becoming Club Champion. Congratulations also to all the other singles and pairs competition winners and commiserations to the runners up. The finals were played over two days and were well attended and the spectators enjoyed the competitive spirit between the bowlers. My thanks go to Georgina for providing the refreshments on both days.

I would like to place on record my appreciation to the officers and Committee members for their invaluable support throughout a difficult year for the club. Again I have to say that without their work the club would not function. My compliments go to Les Hazell for his efforts as Secretary and Treasurer, to Dennis Turnbull for his work as Fixture Secretary and Tour Manager and to Dave Lewis for managing the club's website.

The club members also owe a huge debt of gratitude to Alex Rayer, Barrie Williams and myself for maintaining the green and for oversight of the ground maintenance contract. My thanks and appreciation also go to Ray Bridges and Barrie Williams for running the bar and to Sue and Jean Williams and Les Hazell for providing our post match catering.

Finally, I would like to thank all those people who volunteered to carry out any task no matter how small. We are a club who would not exist without your help. The old adage of 'Many Hands Make Light Work' is very true and I look forward to seeing you all working hard again next year. In the meantime winter well.

Cardiff Athletic Hockey 2016-17 Review

The 2016/2017 season followed on from the 15/16 season with continued success and growth of the hockey section.

The men's first team narrowly missed out on winning the competitive National Hockey League, Conference West, through goal difference, but a fantastic display in the European Hockey League (hockey's equivalent to the Champions Cup of rugby) saw them winning against the Italian champions and narrowly losing to the German Champions, this was enough to book ourselves a place in the illustrious competition again next season.

Frustrations over the league disappointment were expressed against local rivals Whitchurch HC in the National men's Championship Cup, with an empathic 8-0 victory in the final, followed up with a convincing win at the domestic indoor finals. This means that we have now earned the right to travel to Prague in February '18 to represent Wales at the European indoor hockey championship.

The club were also very proud that one of our players, Dan Kyriakides, who has been at the club for 7 years, has been accepted into the GB training group for the Tokyo Olympics, earning 5 GB caps during the year.

During the summer of 2017, eight of the current team were selected for the Welsh National Team who played in the European Championships in Glasgow. Wales won a silver medal and promotion into the top level of European hockey for 2019.

This is the 15th consecutive year that the Club has represented Wales in Europe and the whole squad would like to thank the Athletic Club for their continued support of these European ventures and making our continued success possible.

The men's section continues to go from strength to strength with all teams consolidating their positions in their respective leagues with a positive and inclusive attitude to the sport. All teams are competitive in their respective leagues and it is a great credit to the club that we are able to provide such an array of hockey for our members every weekend. Our men's second team are regularly developing players into international youth and senior teams and we are well regarded as the club to play at if you would like an international future.

The ladies section continued to grow its membership this year and fielded an extra team this year to 5 teams in the South Wales League. The ladies first team

consolidated their position in the league with a commendable mid table finish, the ladies 3's were promoted and sadly the ladies 2's and 4's were relegated from their leagues. The 5th team provides an excellent platform for social hockey and they won all of their matches this year.

The club has enjoyed very successful season winning the league and cup at first team level. Our young team, once again led by Greg Holmes, showed great maturity in bouncing back from last year's second place to convincingly win the league. The 2 immediate stand outs for the season include Alex Milton and James Lewis. Alex broke a league record scoring 1,103 runs in the league.
