

#### 10. To Transact any other business

The Chairman read out the following questions from Paul Brewer;

Q. Last year I mentioned my frustration on learning of the changes introduced by the Company on returning to Cardiff Arms Park. In posing that question I could never have anticipated how the planned refurbishment would drastically change the character of our Members Lounge. The loss of the alcove seating, the colour scheme, ( there is probably less scarlet in the Llanelli clubhouse) and the replacement lino now make it look more like a student's union café bar than a rugby club.

Please can you confirm if new alcove seating is planned, and when will the correct club colour scheme replace the current scarlet and grey branding colours?

My question is generated by Section 9 of the Report, page 9, paragraph 6, under: To transact any other business. 'Many of you will be wondering.........'

Q It would appear from reading that section of the Annual Report that 'They' (presumably The Company were already considering the type of refurbishment to be carried out as early as the 19th of November 2013, with the intention of then using the Members Lounge for 'more corporate use'. Does this represent a change in the leasehold agreement? If so, I would like to know when this was agreed by Management. If this change has been agreed, then I am concerned to know how the Company is able to use our Private Members Lounge for Company Business.

It is clear that this paragraph in last year's report clearly sheds light on the reason, nature and style of the refurbishment, and it appears to have been carried out not for the members benefit, but for future corporate use."

Keith Morgan explained that the only way to sustain the Clubhouse as a business was to use it for corporate facilities during the week. If they were to rely on just match day income then the Clubhouse would be closed Monday to Friday. Unless we use these facilities as a corporate venue, I do not see any other way of sustaining this as a business. The members do not use the Club to any great extent, so we are to keep it open and try and attract a new audience. But to confirm, there was no conspiracy, we have never hidden the fact that we want to encourage more people to use the club on non-match days. It was passed by management 5 years ago and it has been reported repeatedly in AGM that we have been trying to encourage new customers. Whilst there may be an apology due for the way it has been done, the reasons behind it are not to detract from the members' rights or comfort.

The next letter was from Jean Monk. The letter was read out and alluded to the fact that she was not happy with the new furnishings and colour scheme in the Members Lounge. Mrs Monks question was;

All the people I know who have complained to Richard Holland have been told that the plans were passed by the Cardiff Athletic Committee. If so what on earth were you thinking or was it that you had sketches with no detail of colours or types of seating? Why did you approve the plans and – in view of the general dissatisfaction with the outcome is there anything you can do about it.

KM responded that this is an Athletic Club and members of the other section Tennis, Hockey, Cricket and Bowls all quite like the new design. KM also noted that the other sections pay more for their membership than the rugby members.

Fred Davies – Do you have a business case to demonstrate how successful it has been? You have mentioned that some now go to Weatherspoons and some of my friends have now started to drink elsewhere. The attendance on match days and international days has been reduced. I would like to know what the gross and net income is compared with the same period last year. We are where we are but we were not consulted, it did not have to extensive details but simple plans should have been shown to members

KM – I understand that some members and shareholders were shown the plans. Jan Cummings had seen plans for the Bar, probably before I had.

Jan Cummings – we attended the shareholders meeting and Mr Holland at the end of the meeting invited the shareholders to see the plans at the end of the meeting. My friend and myself went to look and it was just a design on show with no colour scheme indicated. We did not like what we saw as we thought then it looked like a coffee shop. We pointed out to them that there was not enough seating and Mr Holland agreed that this would be looked at.

Richard Husdon – We were told in the summer that there would be an open evening.

Richard Holland – As CEO of Cardiff Blues I would like to allude to decisions that were taken and the process that was followed to get us to the point that we are now at. When we moved back from the Cardiff City stadium I hope that you

can see that we have done huge amounts for the development of this stadium and the Club House. I take your points on board regarding the Members Lounge downstairs, but I think that we should be commended for the developments that we have made elsewhere in the stadium. We identified that the main bar downstairs needed some resources spent on it so we embarked on a project. We engaged an interior design company to put together a design that you now see down stairs. The design process was put to the Management Committee and was agreed. We have listened to the remarks and comments that we have received. Having previously worked at Celtic Manor and Chepstow Racecourse the numbers of comments that we received were minimal. We have listened to the comments and have engaged our contractors to put additional furniture in place, we are looking at the colour scheme, and I am encouraged at the positive feedback that we have had.

In terms of the financial numbers, the revenue is up 15% on previous years in the same period. We are committed to continuing improving the facilities. I would like to note here that Keith and the Management Committee have contributed to the improvement of the downstairs bar. We are also installing a trophy cabinet in the next few weeks so we can share some of the treasures that are currently in our trophy room. I am encouraged by the visitors that have been here and say how fantastic the facility it. There is no malice in what we are trying to do and we are open to suggestion and change. We are committed to making this one of the best Clubs in Europe and to continue to uphold the values of Cardiff RFC and Cardiff Blues in the world of rugby.

Richard Hudon – Why don't you encourage for people to come into the club and use the facilities? I was always told that we could not advertise as it is a private members bar. There was no food here for a long time, and now all you can offer is 3 pies, there are also muffins and cookies and a coffee machine. You do not use the coffee machine on match days because of health and safety. I know that the coffee machines are very expensive so where is the value?

RH – the bit that concerns and disappoints me is the members who do not use the facility. We are relying on outsiders to supplement the fact that the members do not use their bar.

Richard Hudson – People don't use the Club because there is no food, and there is no food because people don't use the club.

Dave Lewis – I was one of the best members of this club, it was virtually my second home, however after what you have done to the Club and made it so uncomfortable means that I have now moved to another club.

Michael Peterson - My problem is that I need to sit down. The number of times I have come in after a game and all of the seats have been taken. It comes to something when the basic requirements of a bar are lacking. I like the decoration. However there have been at least 2 occasions where the bar has run out of beer. It is a fundamental error when you are unable to serve beer.

Keith Morgan - What I have suggested at a meeting I had last week was that we

do want more furniture, we do want some more comfortable sofas. What I suggest is that with the additional sofas, we can create our own alcoves.

Can I please ask you a question – Is the price of beer around town a factor in where you drink? If the furniture and room was improved, are you happy to pay the bar prices that we charge?

Michael Pearson – I am very happy to pay, however there are others to whom the 20p price difference does make a difference.

Mark Wakeham – Can you please confirm if the sales figures you quoted stating that sales are up 15%, is that a year on year comparison?

Keith Morgan – I can confirm that the figures are based month on month with same period last year

Mark Wakeham – My second question is why Red and Grey which are the colours of Llanelli?

Richard Holland – We put the colour scheme together with a team of interior designers. I am sure that as a Cardiff RFC supporter you will remember that Cardiff have previously had a change strip of red. We put the colour scheme to the committee of the Athletic Club and it was passed and agreed. As you look around the ground, you can see that we are awash with Blue, and in keeping with a modern design concept, and in consultation with many people that is how we ended up with the final design. People have personal preferences, and although you may not like something it does not mean everyone feels the same way.

Keith Morgan – Looking around the room, I know that I have spoken to at least 75% of you about the very things that we are talking about now. We have a Board meeting on 9th February and the feelings from this AGM will be put to the Board. If changes have to be made, we will make them. However you must also understand that any changes that are made will not be done before the end of the season as we cannot afford to close the Club during the season.

Dave Lewis – I am quite happy to pay £3.40 a pint as long as I am comfortable and in a place that I like to drink. I now drink in Llandaff Institute and it is £2.93 a pint. That does make a difference when you are in there for three or four hours. A lot of people in here do not drink downstairs because of the price of the beer. The competition is in Weatherspoons, and it is £1.99 a pint.

Fred Davies – Mr Holland, I still feel that you have not answered the question about the consultation process. You used a professional design service who are used to providing coloured drawings to a reasonable scale to show a before and after effect. It feels to me as a long standing member of this Club that you do not have a handle on the demographics of this Club. There are many other establishments locally with a similar feel to them, however I do not understand what demographic group you are aiming the Members lounge at. You have certainly not considered people who I sit with and what is important to us.

Richard Holland – In short, a full design concept with colour scheme was provided to the Management Committee of Cardiff Athletic Club.

Keith Morgan – The management Committee did see the plans, and my reservation was Scarlet. The majority of the Management Committee were reasonably happy with the design, however we were not aware of the metal stools. The red colour was always going to be like a red rag to a bull. Richard Holland has come here this evening to judge the feeling of the membership and to take it back to the Board to decide what to do.

The original design had a glass wall going into the trophy room, which was sadly out of our league financially. We were originally going to keep the alcoves, until they took them apart and discovered that they were rotten. It would have been too expensive to put them back. We have to make the best of what we have got and adding into that some more comfortable furniture. We are about 60/70 seats less than what we were previously. The additional furniture will be delivered in 4 to 6 weeks so probably by the end of February.

Fred Davies – Can I please ask that before any further changes are made to the Members lounge, can we have a resolution to undertake a consultation process with the members.

Keith Morgan – To repeat my answer to your last question, the plans are to put more furniture in and in time to review the colour scheme. What plans do we need to do that? Richard Holland has come here tonight to listen to what you feel the problems are with the members bar, as we are trying to work together. We understand what the problems are and we will address them. I cannot commit that there will be a change in the colour scheme, however as a management committee we can ask that this is taken forward

Brian Bennett – It was agreed at our meeting this evening that the Management Committee will request Cardiff Blues to provide additional furniture and also ask that the red colour be changed. There will be a trophy cabinet installed, and there are some more pictures to be displayed which will take away from the effect of the grey walls. We have got to move forward, there will be improvements and the Management Committee will take this forward.

Richard Holland – The Club house is here to serve the members of the Athletic Club and it was not being utilised. We have made some changes and the utilisation has increased. We will listen to and change anything that is required to placate the members, I am not here to try and upset anyone, I do not want to put in place anything that people do not want. We want to provide you with a bar and a facility that is vibrant and that the members can use. If all of you use and spread the word to your family and friends to use it then that can only be a good thing. I find it sad that people are so negative about what we have done and the resources that we have spent on it. Since moving back here from the Cardiff City Stadium, we have done huge amounts to take this Club forward and I hope that all of you can engage with that. I take all of your points on board, I have said to Keith and the Committee that we will do anything that we need to do to make sure that you as Members have a facility that you can be proud of, can bring your friends and families to and hopefully we can move forward together.

Dave Lewis – Mr Holland , we think that what you have done out there is great and you have done a fantastic job. The bowls section used to come in here every Tuesday afternoon – and you closed it.

Richard Holland – But is now open every day.

Dave Lewis – You cannot blame us for not coming in here as you closed it.

Richard Holland – But is now open every day.

Richard Hudson – I came to a game a few weeks ago, and as I walked through town, I noticed a Bill Board advertising "the Nuggett" and blue and black burger to the recipe of Martyn Williams. This is the sort of thing that we should be doing. I used to regularly come here for a meal, and then eventually they stopped serving food. Now there are 3 pies. If you want to attract people to come in at lunch time you have got to provide them with food. Also on match days – if you come in here on a match day the only food available is a pie in a cardboard tray with plastic cutlery. When people have come in for a roll – they have run out, for a bag of crisps, they have run out. There is no continuity of food except pies, can you please improve the food that is served in the Club?

Keith Morgan – I come to this Club every lunch time and I have been for the last 7 years. I used to eat in here at lunch time too. However, when they were serving food, they would have been lucky to serve 3 or 4 meals a day. To take a chef on would not make financial sense at the moment. I understand that it is a chicken and egg situation. However, there were not many people who would eat in here. The original reason for stopping the food was that the dumb waiter stopped working. However the Athletic Club forced the limited company to spend £14k to replace it. But still no one came. What I would like to ask if would you use the Club more if there was food available?

Consensus - Yes if it was of a good standard.

Keith Morgan – And here lies the problem, we can not sell cheap meals as we would not have the turnover that establishment like Weatherspoon's have. They can sell meals with a drink for £4.99, however, we would have to start our pricing to get food of a good standard at £7 to £10.

Richard Hudson – over the years I used to come in at lunch time and the clientele that you had were getting older. I know that a lot of the people that I used to see are now either dead or infirm. You have to try and attract a younger group of trade.

Keith Morgan — we do need to improve things. They have recently bought a panini maker which will appeal to the younger element. The Club is now open from 8am to hopefully catch people parking their cars, so that instead of them going to Costa coffee, they will come in here for their coffees and muffin etc. It is being used reasonably well on the coffee side. I agree with you Richard, I too would love it if they were to now start serving food again.

Richard Hudson – What are we doing to encourage people to use this in the evenings?

Keith Morgan – As we look around this room it is the same faces all of the time, the same people who attend meetings, where are the other 1400 members?

Alan Priday – I think that since the drink and drive laws have become stricter, it has become difficult to encourage people to use the Clubhouse during the week. We need to encourage people to use the club more in the week. We have a good facility here and it should be used more.

Keith Morgan – you would be amazed that people still think that we are a secret society and that they are not allowed in the club.

We need to have signage saying welcome to Cardiff Arms Park, visitors are welcome. Whilst on a match day we cannot accommodate this, during the week and on non match weekends, we should be encouraging people to use our facilities.

To draw this to a conclusion, we take on board your comments and we will continue discussions with Richard and the Board at the next meeting.

Meryl Jenkins – you say that the bar takings are up by 15% since the refurbishment, I was here on Saturday night and left at 10, and there were 15 people downstairs and 7 people upstairs, how can the takings be up when there are so few people here at 10 o'clock on a Saturday night after a prime game for the Blues?

Keith Morgan – I was here from 12 noon on Saturday and watched the game, however I went home at 7pm as I had had enough by then. However the figures also relate to people using it in the week.

Richard Hudson – I have been here when there has been smaller games here, and the club shop has been closed, even though people wished to purchase or browse. Can I suggest that we open the shop more.

Richard Holland – the retail side of the business is being looked at and we will address the opening hours, however I am not sure that this is entirely appropriate to discuss here.

Keith Morgan - I agree.

Richard Holland then left the meeting

Keith Morgan – I think that we need to give Richard and the Blues credit for the improvements that they have made to the ground. The changing rooms have been completely refurbished to European standards with ice baths. So I do think that they have spent a considerable amount of money on the ground. There is no malice in how the refurbishment has been carried out, they may have made a mistake, but it was not maliciously done.

The plan is to continue the development, hoping to look at possibly improving the top lounge. However, we have made it very clear to them that they must preserve the heritage of the Club and make sure that the pictures and boards remain on display.

I would like to take this opportunity to thank you for sticking with the Club during the refurbishment. I would also like to thank you for your concern, its nice to know that we have 60 people here who care enough about this great Club to attend this evenings meeting and express your concerns. It would be good to encourage more members from all sections to use the Club, then it would give us greater scope to expand the catering options on a daily basis.

As there were no further questions the meeting was concluded.

## INDEPENDENT REPORT OF THE AUDITORS TO THE MEMBERS OF CARDIFF ATHLETIC CLUB

We have audited the financial statements of Cardiff Athletic Club for the year ended 31 May 2015 which comprise the Income and Expenditure Account, the Balance Sheet and the related notes. The financial reporting framework that has been applied in their preparation is United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice)

This report is made solely to the club's members, as a body. Our audit work has been undertaken so that we might state to the club's members those matters we are required to state to them in an auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the club and the club's members as a body, for our audit work, for this report, or for the opinions we have formed.

#### Respective responsibilities of Committee of Management and auditor

As explained more fully in the Committee of Management's Responsibilities Statement, the Committee of Management is responsible for the preparation of the financial statements which give a true and fair view. Our responsibility is to audit and express an opinion on the financial statements in accordance with International Standards on Auditing (UK and Ireland). Those standards require us to comply with the Auditing Practices Board's (APB's) Ethical Standards for Auditors.

#### Scope of the audit of the financial statements

An audit involves obtaining evidence about the amounts and disclosures in the financial statements sufficient to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or error. This includes an assessment of: whether the accounting policies are appropriate to the club's circumstances and have been consistently applied and adequately disclosed; the reasonableness of significant accounting estimates made by the Committee of Management; and the overall presentation of the financial statements. In addition, we read all the financial and non-financial information in the Annual Report to identify material inconsistencies with the audited financial statements. If we become aware of any apparent material misstatements or inconsistencies we consider the implications for our report.

# CARDIFF ATHLETIC CLUB ACCOUNTING POLICIES FOR THE YEAR ENDED 31 MAY 2015

#### BASIS OF ACCOUNTING

The accounts are prepared on the historical cost basis of accounting and in accordance with applicable accounting standards.

#### INCOME

Income is accounted for on a receivable basis.

#### FIXED ASSETS

Freehold land and buildings, and other tangible fixed assets are stated at cost, less accumulated depreciation where applicable.

#### **INVESTMENTS**

Investments are recorded at cost. Provision is made, where necessary, for any permanent diminution in value.

#### DEPRECIATION

Depreciation is provided on a straight line basis on fixtures / ground equipment, office furniture / equipment, tennis court / equipment at a rate of 25% per annum.

No depreciation has been provided on freehold or long leasehold land and buildings. The Cardiff Arms Park is let under a full repairing lease and has to be maintained in accordance with Sports Ground Legislation, such that the value does not diminish over time. The Management Committee are of the opinion that the market value of the land is greater than the value at which the land and buildings appear in the accounts. As a result, the corresponding depreciation would not be material and therefore is not charged in the Income and Expenditure Account. The Freehold Property at Lisvane is newly built and is subject to a maintenance period.

The Management Committee perform an annual impairment review in accordance with the requirements of FRS11 and FRS15 to ensure that the recoverable amount is not lower than the carrying value.

# CARDIFF ATHLETIC CLUB COMMITTEE OF MANAGEMENT'S RESPONSIBILITIES STATEMENT FOR THE YEAR ENDED 31 MAY 2015

#### Statement of the Management Committee's responsibilities

The club rules require the committee to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the Club and of the income and expenditure of the Club for that period. In preparing these financial statements, the committee is required to:

- i) select suitable accounting policies and then apply them consistently;

#### CARDIFF CRICKET CLUB 2015 Season Review

I would firstly like to thank my predecessor Matt Phillips for all his hard work in the last 7 years. I took over a club in excellent shape, the adult teams performing consistently well, we have a vibrant and successful youth and a wonderful ground.

The 2015 season was another successful one for the club. The 1st team came second in their league while the 2nd team won again. We continued to run 4 teams on a Saturday and the respective captains of the third and fourth teams, Darren Swart and David Ricketts should be congratulated on their efforts to raise competitive sides.

With the 1st team having won the league and cup the year before it was always going to be hard for new captain Greg Holmes to repeat the success but his team performed well with a very young side.

An indifferent start to the season put us on the back foot in defending our title, however a stunning win against Pontardulais, where David Kirtley starred with a magnificent 116\* chasing 254, sparked a 2 month league and cup run where we were only defeated by league champions Bridgend.

In this period stand out batsman Alex Milton consistently performed with the bat (876 runs at an average of 55) and James Lewis (37 wickets) stepped up to lead the bowling attack and claim his maiden 5 wicket haul. A notable performance against Blackwood, inspired by Mathew Preece and Alun Thomas, the pair striking 8 6's between them to get the side over the line in what seemed to be a lost cause chasing 234 in 40 overs.

Unfortunately we could not catch Bridgend in our title defence, but finished runners up. In the Welsh cup we narrowly lost out to eventual winners Colwyn Bay in the semi final, with a great fight back from the team to take the game to the final over.

In the second team new captain Gwyn Hobbs led the team with distinction. Our aim with this team is to offer high quality cricket to as many younger players as possible under the guidance of our senior players. To have won the league by over 50 points, at the same time as blooding so many youngsters, is a credit to Gwyn and his senior teammates as well as to the quality of youth cricketers we have at our disposal.

With the bat, there were many fine contributions, including: Gwyn scoring 525 league runs (including 2 hundreds at an average of 75); Anush Patel, Dafydd Manley and Ian Bridgeman all scoring 300 league runs at averages of 43, 31 and 33, respectively (which included one hundred for Anush); Andrew Thomas and Umar Malik both scoring 250 runs at an average of 31; Mathew Preece striking two rapid half centuries; and Dewi Preece making the team's top score with a superb 162 not out. Dan O'Sullivan really impressed with the ball taking 33 wickets to end as the leading wicket taker in the league (taking 4 wickets in an innings on 7 occasions), and Anaesh Patel and Tom Barry both bowled very well to take 18 and 15 wickets.

In the third team Darren Swart continued his good work from 2013. The majority of 3rd team cricket is played against other 1st teams meaning they are primarily adults against our team which is invariably a team of older players and promising youth.

The 3rds finished 5th in the league with notable performances from James Meggitt and Will Mably with the ball and Umar Malik with the bat.

The 4ths enjoyed the 2015 season finishing third in the welsh cricket conference division five despite using 39 players. Notable performances were hundreds from David Ricketts (719 runs at an average of 72), David Herbert and an unbeaten 184 from Jonathon Good as well as 21 wickets from promising young seam bowler Tom Watson.

The mid week team run by Mathew Preece won the league cup competition.

Special mention should be made for David Kirtley and Ian Bridgeman who announced their retirement at the end of this season.

David has played for 16 years and scored over 10,500 runs. He has been a successful club captain and has been ever-present in the 1st team since he joined the club.

Ian has played for the club since he was a child as an aggressive and flamboyant opening batsman with a fear of slow spin bowling.

Their attitudes, experience, skill and humour will be greatly missed and we hope to see them supporting the club next year.

#### Youth

The junior section had another successful year with pride of place going to the U15 age group who won the Welsh Cup at SWALEC Stadium as well as retaining their Cardiff and Vale league title. Congratulations to Tom Bevan and Mujahid Ilyas who represented West of England at the prestigious Bunbury Festival. The club was very proud to see Kiran Carlson receive Glamorgan Academy Player of the Year for the 2015 season. It is a real credit to the club and the youngsters that we have 3 players in the academy in Kiran, Prem Sisodiya and Mujahid Ilyas.

The U13 squad also won their league whilst several U9 players show potential for the future.

The youth train on Friday evenings and I encourage members of the Athletic Club to visit in the summer. We tend to have around 100 children playing with many parents watching and enjoying a BBQ. We see this as a crucial part of the club and we are delighted to see so many youth players representing the club at the senior level.

In this year we employed our own groundsman Tim Walden to help ensure our ground remains one of the premiere facilities in the region. This development has been a success and we thank Tim for his hard work as well as Chris Fowler for his continued commitment to developing the ground.

In summary we have enjoyed a successful season throughout the club. At 1st team level our young team will be a year older and more experienced next year and we will continue to challenge for honours. Our youth remains strong and we believe the club is in a strong position. We greatly appreciate the support from the Athletic Club and hope to see members of all divisions at our ground in 2016.

# Cardiff Athletic Hockey 2014/2015 Review

The 2014/15 season was one of continued success and putting in place a sound structure to build upon and increases expectations even higher.

The men's first team kept up their impressive record in the National Hockey League, Conference West, suffering only 2 defeats all season and narrowly missing out on winning the championship on the last day of the season. This was the first time that the side had not won the title in three seasons and the side vowed to make amends the following year.
